




## Between the Columns

#### What kind of stone are you?



A stone building is made up of many different kinds of stones. They do not all look alike nor work the same. It has wall stones, much larger foundation stones, corner stones, cap stones, door frames, window sills, decorative and carved stones in it.

Freemasonry builds individually, with stones and men. One at a time, each is proofed, measured and gauged. The stone squarers did the same thing when working with the raw material; each in his own way following the prescribed end result and each stone for its own special purpose. And when these were ready, they were stacked one upon the other to build.

So often we specialize in rectangles and cubes. These are very important building parts, but in a larger setting we need more than these. For this reason we should not use the cookie cutter approach to Masons. Sometimes fellow Brothers look different than the rest and just don't fit the mold set by previous generations.

This is all right. The modern man who seeks admission to come into our fraternity has the same goals as those of us who came before them, the same seeking for a higher form of human development and the same morals as every other generation. They have the same questions and the same yearning. But they were born, raised and taught in a



different world; one which included computers, the internet and lots of color and action. If our goal is to teach these men self improvement, then we need to rethink how we do this. And we need to realize that many men fit a different set of plans.

We should provide as many opportunities as we can for the newly made brethren to look over, choose from and progress with - all within boundaries set by our ritual, principles and goals, and doing so with the most modern equipment and themes we can.

The simple working tools we learn so much about in the Blue Lodge degrees do a good job roughing out our stony exterior, but it is the higher lessons that really teach us about the internal. And that is what is found in the Scottish Rite. Only so much can be gleaned from old encyclopedias, deep musky books and unreadable manuscripts. The rest of the shaping comes from personal interaction with what you have been taught, a mindset that aims high and being with like minded men.

All this may sound foreign to some. So let's look at what is taught about building in the early

degrees. Take the five columns as an example. Each of the five shows us a progression, but also variety. They are each different from each other. They all seem to work well. Some are a little more fancy or associated with a



certain building phase; but that is all. Is one of the five ways of architecture better than the rest? No.

Now is the time to start collecting / submitting those petitions for the 37<sup>th</sup> Consecutive Fall Reunion to be held November 11-13, 2010. We have a goal of 100 members over the next 12 months. It is going to take all of us to reach this goal!

### Just My Opinion ...

I curiously wonder what causes people to do, or not to do, certain things. Is it motivation or reward; both; neither?




The *Encarta* dictionary defines motivation (noun) as "**giving of reason to act**: the act of giving somebody a reason or incentive to do something; *or*, **enthusiasm**: a feeling of enthusiasm, interest or commitment that makes somebody want to do something, or something that causes such a feeling; *or*, **reason**: a reason for doing something or behaving in a particular way." To me, this is a mental and/or emotional action.

The *Encarta* dictionary defines reward (verb) as "**give somebody something as reward**: to give somebody something in return, especially in thanks for kindness or help; *or*, **repay effort**: to be worth the effort or attention that is given." To me, this is a physical action.

I listen to brethren using these two (2) words interchangeably or as mutually exclusive. In my personal philosophy, I find that they actually work quite well when used together. The mental (motivation) is necessary for the action to be undertaken; the physical is often necessary for progress and success.

The Scottish Rite has many challenges, not the least of which is membership. But hearing about the subject grows boring, cumbersome and deflating for many. It becomes a so-called impossible task supported by numerous excuses. The challenge becomes one of motivation *and* reward. We must find the proper motivation for *our* Consistory. We must also find the proper reward. To be successful is no longer enough.

Our multiple generations are not on the same page very often it seems. The expectation and rewards of our older members do not meet the techno-savvy expectations of our younger members and prospective members. I think the future lies with our youth and their leaders, but we cannot forget to include our experienced and wise mature generation. We have to bridge the gap, trust in the strength of the fraternity and make the tough decisions. Some people will not like the actions taken but we can't let these few serve as obstacles of change and progress. The Great Architect of the Universe cannot solve all our problems for us. We must put our mental and physical capabilities to bear and directly confront this issue. Anyway, that's my opinion.



#### \$30,000 in Scholarships Awarded to Five Outstanding Graduate Students

The September 20th Stated Meeting program for Denver Consistory was devoted to the annual Scottish Rite Foundation program honoring the 2010 graduate student scholarship recipients. The speech pathology scholarship recipients received their awards during the summer for the following scholarships:

- Two \$5,000 Dwight A. Hamilton/Scottish Rite Foundation Graduate Scholarships in Speech-Language Pathology (The Hamilton Scholarship is administered by the Scottish Rite Foundation.)
- Two \$5,000 Colorado Masons' Benevolent Fund Association Graduate Scholarships in Speech-Language Pathology (The Benevolent Fund Scholarship is administered by the Scottish Rite Foundation with funds gifted to the Foundation for this purpose.)
- Two \$5,000 Sam and Millie Hilburn Scholarships in the Field of Childhood Language Disorders (The Hilburn Scholarship is administered by the Supreme Council of the Southern Jurisdiction of the Scottish Rite.)

These scholarships are awarded to help students with paying the high cost of graduate work and to encourage more students to enter the speech pathology career field. Critical shortages of speech pathologists exist in most geographic areas of the state and the nation and especially in rural and underserved communities. The Hamilton Scholarship and the Benevolent Fund Scholarship are designed to address needs in Colorado by awarding students who intend to remain in

Colorado. In addition, these students must have completed their first year of graduate studies with a GPA of 3.5 or higher in order to be eligible to apply.

#### Hamilton Scholarship

The Hamilton Scholarship, a one-time \$5,000 scholarship, was created by the Scottish Rite Foundation in 2005 in honor of Ill. Bro. Dwight A. Hamilton, the former Sovereign Grand Inspector General in Colorado. As of 2010, twelve individuals have received this scholarship. Eleven scholarships have been awarded to University of Colorado-Boulder graduate students and one scholarship has been awarded to a University of Northern Colorado graduate student.

#### **Benevolent Fund Scholarship**

In 2003 the Colorado Masons' Benevolent Fund Association partnered with the Scottish Rite Foundation by awarding graduate student speech pathology scholarships to students at UNC. In 2007 the Association made a gift of \$50,000 to the Foundation for scholarships to UNC graduate students over a 5-year period beginning in 2008. These scholarships are made in the name of the Association. As of 2010, sixteen scholarships have been awarded to UNC graduate students.

#### <u>Hilburn Scholarship</u>

In 1999 the Supreme Council of the Southern Jurisdiction of the Scottish Rite initiated a speech pathology graduate student scholarship with an endowment from Sam and Millie Hilburn of Texas. Ill. Bro. Sam was a former SGIG in Texas. The Hilburn scholarship is open to all graduate students in speech-language pathology throughout the United States for study at schools within the country. Scholarships are offered at \$5,000 per year for a maximum of two years of graduate study. In 2010, there were 58 applicants for this scholarship. Five students across the nation received the scholarship, two of whom are at the University of Colorado. Since 1999, four Colorado graduate students have received this scholarship; three for \$5,000 and one for \$10,000.

Hannah Shippey was born and raised in Denver and attended Denver public schools. Hannah's specific areas of interest include autism spectrum, motor speech, and expressive and receptive language. She states, "I believe that early intervention for children with special needs is crucial to their future academic success. I plan to begin my career in the Denver Public Schools, as they currently suffer from a shortage of Speech-Language Pathologists."

Rebecca McNeil spent nearly 15 years in marketing consulting in New York City before deciding to return to graduate school to pursue her interest in child speech and language. Most recently, she was a trainer at the Talking with Technology camp which is conducted by The Children's Hospital and supported by the Foundation.
