Celebrating 25 Years in Grand Junction

The essay by Mrs. Ell titled "A RiteCare Mom's Touching Story" tells us we are on the Rite Track in our 59th year of service to Colorado families. And in Grand Junction we are now celebrating our 25th anniversary of service to the greater Grand Junction community.

On April 14, 2012, the Scottish Rite Foundation of Colorado (Colorado RiteCare) and St. Mary's Hospital and Life Center senior management and staff celebrated the 25th anniversary of RiteCare's work on Colorado's western slope. The celebration took place at the new hospital complex and conference center with over 100 guests and dignitaries in attendance. The event was covered by Grand Junction's Channel 5 television news and featured on the 10 p.m. news that evening.

The expansion of RiteCare services to Grand Junction began in 1986. Through 2011, the Foundation has served more than 1,200 children in the greater Grand Junction community with financial support totaling \$2.6 million.

Grand Junction is the first location outside the Denver metro area for the Foundation's transition to a statewide operation. Prior to 1986 and beginning in 1953, the Foundation provided services only in Denver. It now partners with nine speech-language pathology providers and two early childhood language development providers in 20 locations around the state. The celebration program's Master of Ceremonies was Illustrious Brother John W. Groves, 33°, Vice President of the Board of Trustees for the Scottish Rite Foundation of Colorado and Secretary of the Grand Junction Consistory. In his opening remarks Ill. Bro. John noted that Scottish Rite Masons created the Scottish Rite Foundation in 1953 and what was done in Colorado inspired the Supreme Council of the Southern Jurisdiction and each of the Jurisdiction's other Orients to create similar programs. He also noted that of all persons present, he probably has the longest relationship with St. Mary's as he was born in this hospital in 1941.

A historical accounting of the beginning of the Foundation's statewide expansion was given by Deborah Hayes, Ph.D. who, beginning in 1983 and since, holds the position of Chair of the Department of Audiology, Speech Pathology and Learning Services at Children's Hospital Colorado. Deborah also holds several other important positions including Professor of Medicine and Rehabilitation at the University of Colorado School of Medicine and Co-Chair of the Bill Daniels Center for Hearing at Children's Hospital Colorado. Of great significance to the Foundation, in 2003 it established an endowed chair at Children's Hospital Colorado titled the Kelley Family/Schlessman Family Scottish Rite Masons Chair in Childhood Language Disorders. Deborah holds this Chair and as the Chair, she is responsible for coordinating and

serving in a liaison role for RiteCare programs across the state.

During her presentation Dr. Hayes noted that the Foundation's statewide expansion was the result of the vision and foresight of Foundation trustee and treasurer, Illustrious Brother Lee E. Schlessman, 33°, Grand Cross. In early 1986 Ill. Bro. Lee initiated discussions with her and requested that she review the possibilities and make recommendations to the Board of Trustees. She consulted with Dr. Dennis Mathews at Children's who was very knowledgeable about certain rehabilitation programs around the state. This led to a visit to Hilltop Rehabilitation Hospital in Grand Junction (subsequently becoming St. Mary's Life Center the rehabilitation unit for St. Mary's Hospital & Regional Medical Center) and thus the stage was set. One of the speech pathologists, JoAnn Miller, who Deborah visited with on that important day in 1986 is now at St. Mary's Life Center continuing to work with children. Thus began a statewide program that now serves more than 1,000 children



each year.

The Grand Junction celebration included participation by two senior officials of St. Mary's – Sister Barbara Aldrich, a member of the Sisters of Charity of Leavenworth and a hospital Vice President, and Mr. Kenneth Ferrone, the Executive Director of the St. Mary's Hospital Foundation. Sister Barbara said "We are especially grateful this evening for the 25 years of partnership between St. Mary's and Scottish Rite. Because of this longterm relationship the lives of countless numbers of children have been enhanced." Ken Ferrone noted the numbers 2.6, 25, and 1,226 representing in order the dollars invested by Scottish Rite in Grand Junction being \$2.6 million over a period of 25 years and helping 1,226 children.

The keynote address was given by the Sovereign Grand Inspector General in Colorado (SGIG), Illustrious and Most Worshipful Brother, the Honorable Stephen M. Munsinger, 33°. The SGIG, who is President of the Scottish Rite Foundation of Colorado, talked about our growing and abiding partnership with St. Mary's and commended the leadership of St. Mary's for our shared mission and dedication to helping children communicate.

During the 25th Celebration Ceremony, the Grand Master of Masons in Colorado, Illustrious and Most Worshipful Brother Karl J. Hinkle, also a Foundation trustee, made the event especially meaningful by performing a special Grand Lodge commemoration with a plaque especially designed to be permanently displayed in the St. Mary's Life Center. The Grand Master noted that while this plaque commemorates a successful 25-year partnership, it more importantly symbolizes the Foundation's commitment to working with St. Mary's over the next 25 years and beyond.

A RiteCare Mom's Touching Story Mrs. Ell and Her Family

When my oldest son was 18 months we were painfully aware that something wasn't right. He really wasn't speaking yet. He could say a few basic words like mama, or dada, but that was where it ended. We spoke to doctor after doctor and no one would listen. They would all say that he will talk in his own time.

It took another 18 months for us to find a doctor who noticed right away that he wasn't developing like he should be. The doctor wrote a referral for speech and occupational therapy services. That was our first experience with therapy; it was like a roller coaster ride of appointments and different therapists. It seemed that we could never find the right "fit" for him. He was never able to develop a bond with the therapist and, in return, he wasn't making much progress.

We heard about developmental testing at Children's Hospital Colorado in Aurora. We contacted them and they made the process simple. We were able to get a diagnosis right away. Children's referred me to its Therapy Center in Pueblo. We contacted the Pueblo Center knowing that our insurance did not provide sufficient coverage for speech services. The office was wonderful. They informed me about the Scottish Rite program and how it worked. We put our son on the waiting list and continued to be afraid that this was going to be like all the other programs that he had been in.

When the Center called to say they had an opening, we turned them down. A few months later I put him back on the waiting list. When they called this time we accepted, and we are glad that we did.

Around the same time that our son started therapy in Pueblo, our other son started showing the same signs of speech delay, although not as severe as my first son. Now we were faced with another child who was going to need therapy.

We spent many sleepless nights trying to figure out just how we were going to make this work; how we were going to pay for two kids to get therapy; where would we get the time and strength to do it all over again.

For 18 months our other son got services in the home. When those ended we knew that we needed to do something. It was at that time we were told that Scottish Rite would be able to help with his therapy also. So began his journey.

Since becoming involved with the Scottish Rite program and Children's Therapy Center in Pueblo our kids have made huge improvements. They have been treated like a family, not patients. They look forward to and get really excited on therapy days. Even though they still have a long road ahead of them, it was made easier thanks to the Scottish Rite program and all the staff at Children's Therapy Center. Our family will never be able to repay all the kindness shown over the last couple of years.


For those of you who are on face book, we now have our own facebook page, "The Knights of St. Andrew, Denver consistory". Please feel free to join our page.


Another Memorial Day




