

## Deborah Hayes, Ph.D. Retires "Well Done, Thou Good and Faithful Servant"

The Scottish Rite Foundation of Colorado and the Scottish Rite Masons of Colorado bid a fond farewell to our dear friend and colleague of many years. On July 31, 2017, Dr. Deborah Hayes retired, completing 34 years of faithful service with Children's Hospital Colorado and the Scottish Rite Foundation. The following are several of many notable highlights during her tenure with these organizations:

1. When Dr. Hayes came to Children's in 1983, the only location serving children with speech-language disorders was at the hospital then near downtown Denver. Since then, RiteCare funded services have been provided through clinic facilities in 21 communities across the state.



These services are provided either by Children's (now in six of its locations from Broomfield to Pueblo) or 10 other speech therapy or early childhood language and learning organizations. Dr. Hayes spearheaded each expansion initiative, identifying prospects, making recommendations, and implementing the partnership. The additional 10 RiteCare partners became affiliated with us between 1986 and 2015.

- 2. During Dr. Hayes' 34-year tenure, 16,628 children in Colorado received RiteCare services. This represents 83% of the total number of 20,017 children served by Colorado Rite Care since 1953.
- 3. In 2012 Dr. Hayes initiated an internet-based telehealth program, Telepractice. This makes possible certain functions, such as speech therapy, to be provided through a video-conferencing mode for children and their families in Colorado who are distant from clinic facilities.
- 4. Dr. Hayes also made many notable advances in our RiteCare Program such as (1) the Treasure Chest Program in 2000 focused on early language development, (2) the Graduate Scholarship Program in 2003, and (3) most recently, the Community Benefit Grants Program in 2017.

In 2003, Deborah became the inaugural chair holder of the \$2 million Kelley Family/ Schlessman Family Scottish Masons Chair in Childhood Language Disorders awarded to her and Children's Hospital Colorado. This Chair was passed on to Deborah's successor, Dr. Kristin Uhler, on August 1, 2017.

Not only are thousands of children and their families beneficiaries of her leadership and

vision, but also we in the Scottish Rite are equally gratified and blessed not only to have worked with her, but also to have counted her as a true friend and colleague. We wish her and her husband, Jim, all the best in the years to come. As we say ritually, "Well done, thou good and faithful servant."

#### And now ... A Warm Welcome to Kristin M. Uhler, Ph.D.

Deborah Hayes' Successor as the Kelley Family/Schlessman Family Scottish Rite Masons Chair in Childhood Language Disorders

Please join with us in welcoming Dr. Kristin Uhler to the RiteCare Program. On August 1, 2017, Dr. Uhler succeeded Dr. Hayes. We warmly welcome Kristin as the Chair of Audiology, Speech Pathology, and Learning Services at Children's Hospital Colorado and concomitantly the Kelley Family/Schlessman Family Scottish Rite Masons Chair in Childhood Language Disorders. You will have an opportunity to meet her at the September 18<sup>th</sup> annual Scholarship Awards Program at Denver Consistory.



Dr. Uhler is a native of Sterling, Colorado, and received her B.A. Degree in Communication Disorders and Speech Sciences from the University of Northern Colorado. Her M.A. Degree in Audiology was earned from the University of Colorado - Boulder. In 2008, she received her Ph.D. in Audiology from CU-Boulder.

Dr. Uhler joined the faculty at the University of Colorado School of Medicine in 2009 and has been affiliated with Children's Hospital Colorado since 2015. She has practiced as an audiologist since 2000 with an emphasis in clinical practice, research, and teaching.

Deborah Hayes and Kristin have been associated over the past two years with respect to faculty research projects and clinical audiology services at Children's. Kristin recently told the Foundation's Board of Trustees:

"I have been impressed by the legacy of the Scottish Rite's extensive programs made possible through the generous and enduring support of Scottish Rite Masons in the state. My respect and admiration for your work is boundless. Honoring the rich history and leadership of the Scottish Rite Foundation of Colorado will be my priority in the years ahead."

We look forward to working with Kristen in the coming years, promoting the mission of the Scottish Rite foundation and ever-striving towards our vision of giving every child in Colorado with speech and language disorders the opportunity to receive treatment and care.

Moreover, a total solar eclipse hasn't run coast-to-coast since 1918. Racing eastward at roughly 1 mile every 2 seconds, the lunar shadow cuts through central Idaho, Wyoming, Nebraska, and Missouri. Totality lasts longest just south of Carbondale, IL. The swath of darkness continues across Tennessee and South Carolina, exiting northeast of Charleston, SC.

I chair History and Archives for the Rocky Mountain Conference of the United Methodist Church and with members from conferences, we met in Alaska for a five-day meeting. We heard speeches and attended workshops on the importance of history which laid the foundation of our church. I worshipped in a Russian Orthodox Church in which I stood for the whole service. When the membership was over 3,000, they authorized the construction of our present historic building, which was dedicated on May 14, 1925. This is a date we should certainly celebrate. Senator Henry Moore Teller was crowned the first SGIG in Colorado on October 18, 1882. On October 22, 1919, the Rocky Mountain Consistory was chartered. They met at 1770 Sherman Street for 73 years until they merged with the Colorado Consistory to form what we now know as the Denver Consistory in September 1992.

The present building contains a 500-seat auditorium and a 250 seat dining room. The Denver Consistory is proud to be a part of the downtown community, hosting many events such as the Channel 9 Health Fairs. Our Cathedral Room is the regular meeting room and our main gathering area for reunions, funerals, and so on. It is a special place and I consider it a sacred space as well. I have prayed in there many times, other than at our meeting times.

I also have a sacred place in the mountains to which I go for prayer. We all should have that special place for prayer, silent reflection, and to be alone with the GAOTU.

Have a great summer and remember to be positive, upbeat, and a light for those around you.


