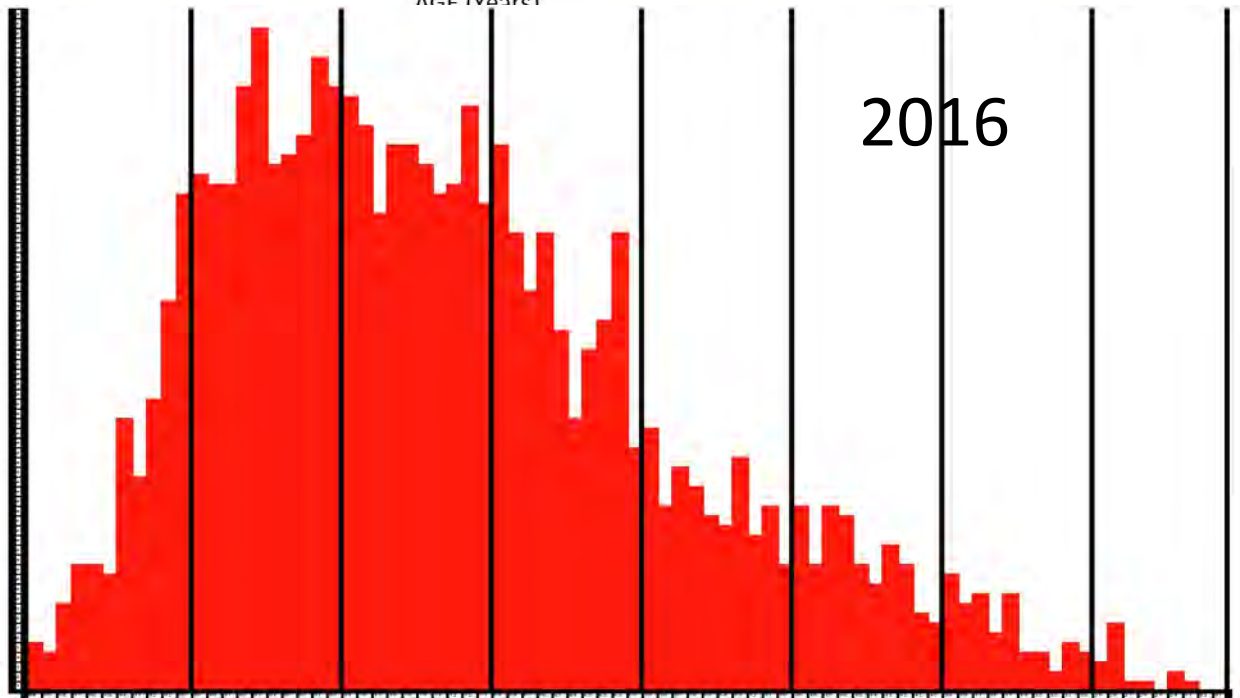
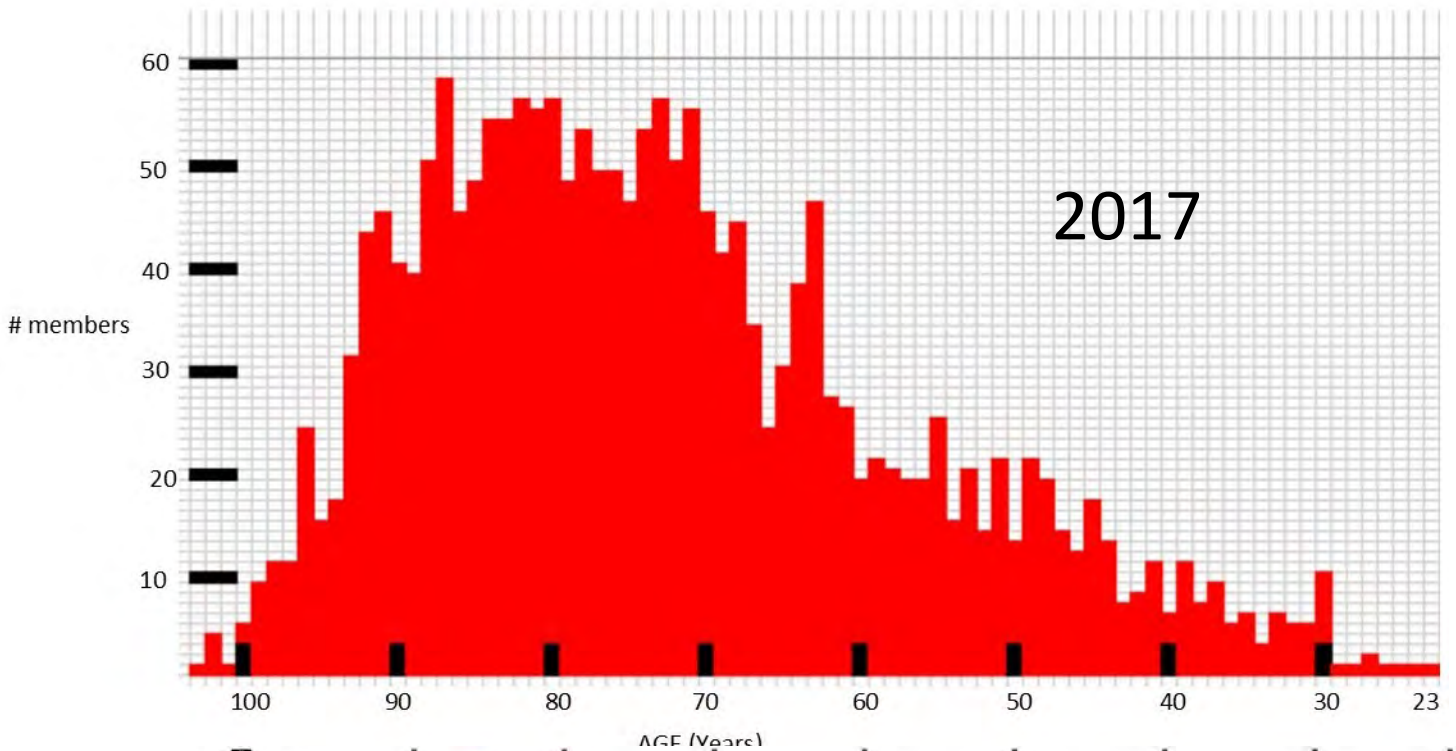
# EDITOR'S CORNER

Along about a year ago, I did one of my “engineering” analyses on the Consistory’s membership versus age. Well, I did it again this year. Take a look at the two graphic displays of our membership versus age and compare how they look from year to year. See much change?



I don't see much difference between the two years, yet we've lost a lot of brothers to death and NPD's, and we've gained a number of new brothers in the interim. But, basically, we're in a "holding pattern" - where not much is changing - either in absolute numbers OR the age spread of those numbers. To quote a familiar maxim: If you don't change how you're doing business, why on earth would you ever expect the outcome to change? Since the outcome hasn't changed, doesn't that sort of imply that we haven't REALLY changed how we're doing things? Oh, we have changed a bit of the way we hold meetings, but do we see more of our new brothers coming to the next stated meeting? No. Do we see more and more of the new brothers engaged in Consistory activities? Maybe, but maybe not in the overall sense. Ask yourself WHY? And, don't be afraid to be candid, and brutally honest with your observations. Because we can't possibly make the changes our younger brothers expect and need for them to replace us if we don't understand what they are and why they're important. The numbers, from all over the country, simply don't lie—the "good old days" of Masonry when we were exploding with growth—are gone, probably never to return. That's reality. So, we need to be real in the examination of our processes and procedures - and note, I did NOT say we need to change our VALUES.

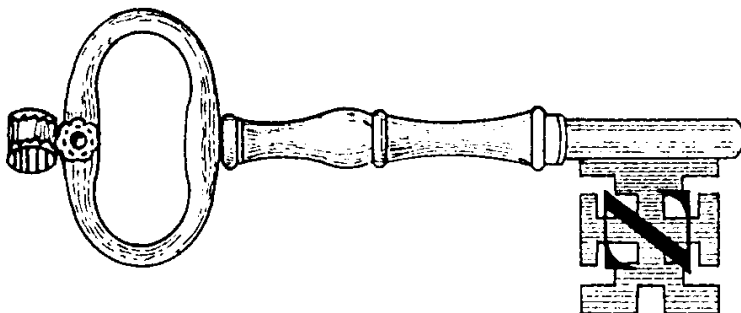

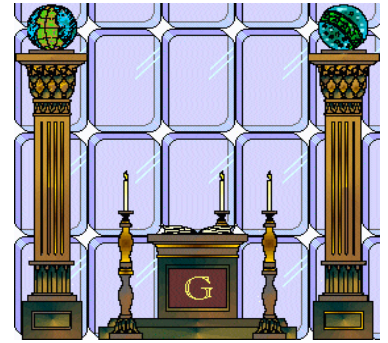
