You know, we often speak of wanting more "light" and spreading "light" to others around us. While this piece is a bit whimsical, it serves to show us that sometimes, "sucking dark" is what we really need to do sometimes. Be that "dark sucker" that goes around eliminating the dark.

For years the electrical utility companies have led the public to believe they were in business to supply electricity to the consumer, a service for which they charge a substantial rate. The recent accidental acquisition of secret records from a well-known power company has led to a massive research campaign which positively explodes several myths and exposes the massive hoax which has been perpetrated upon the public by the power companies.

The most common hoax promoted the false concept that light bulbs emitted light; in actuality, these "light" bulbs actually absorb DARK which is then transported back to the power generation stations via wire networks. A more descriptive name has now been coined: the new scientific name for the devices is "DARKSUCKER."

This paper introduces a brief synopsis of the darksucker theory, which proves the existence of dark and establishes the fact that dark has great mass, and further that dark particles (antiphotons) are the fastest known particles in the universe. Apparently, even the celebrated Dr. Albert Einstein did not suspect the truth, that just as COLD is the absence of heat, LIGHT is actually the absence of DARK.

Scientists have now proven that light does not really exist! The basis of the darksucker theory is that electric light bulbs suck dark. Take, for example, the darksuckers in the room where you are right now. There is much less dark right next to the darksuckers than there is elsewhere, demonstrating their limited range. The larger the darksucker, the greater its capacity to suck dark. Darksuckers in a parking lot or on a football field have a much greater capacity than the ones used in the home, for example.

It may come as a surprise to learn that darksuckers also operate on a celestial scale witness the Sun. Our Sun makes use of dense dark, sucking it in from all the planets and intervening dark space. Naturally, the Sun is better able to suck dark from the planets which are situated closer to it, thus explaining why those planets appear brighter than do those which are further distant from the sun.

Occasionally, the Sun actually oversucks; under those conditions, dark spots appear on the

surface of the Sun. Scientists have long studied these 'sunspots' and are only recently beginning to realize that the dark spots represent leaks of high pressure dark because the Sun has oversucked dark to such an extent that some dark actually leaks back into space. This leakage of high pressure dark frequently causes problems with radio communications here on Earth due to collisions between the dark particles as they stream out into space at high velocity via the black 'holes' in the surface of the Sun.

As with all manmade devices, darksuckers have a finite lifetime caused by the fact that they are not 100% efficient at transmitting collected dark back to the power company via the wires from your home, causing dark to build up slowly within the device. Once they are full of accumulated dark, they can no longer suck. This condition can be observed by looking for the black spot on a full darksucker when it has reached maximum capacity of untransmitted dark - you have surely noticed that dark completely surrounds a full darksucker because it no longer has the capacity to suck any dark at all.

A candle is a primitive darksucker. A new candle has a white wick. You will notice that after the first use, the wick turns black, representing all the dark which has been sucked into it. If you hold a pencil next to the wick of an operating candle, the tip will turn black because it got in the way of the dark flowing into the candle. It is of no use to plug a candle into an electrical outlet; it can only collect dark - it has no transmission capabilities. Unfortunately, these primitive darksuckers have a very limited range and are hazardous to operate because of the intense heat produced.

There are also portable darksuckers called flashlights. The bulbs in these devices collect dark which is passed to a dark storage unit called a battery. When the dark storage unit is full, it must be either emptied (a process called 'recharging') or replaced before the portable dark-sucker can continue to operate. If you break open a battery, you will find dense black dark inside, evidence that it is actually a compact dark storage unit.

The darksuckers on your automobile are high capacity units with great range, thus they require much larger dark storage units mounted under the hood of the vehicle. Since there is far more dark available in the winter season, automobile dark storage units reach capacity more frequently than they do in the summer, requiring 'recharging,' or in severe cases, total replacement.

Dark has great mass. When dark is drawn into a darksucker, friction caused by the speed and mass of the dark particles (called anti-photons) actually generates substantial heat, thus it is unwise to touch an operating darksucker. Candles represent a special problem, as the dark must travel into a solid wick instead of through clear glass. This generates a great amount of heat, making it very dangerous to touch an operating candle

Because dark has such great mass, it is very heavy. If you swim just below the surface of a lake, you see a lot of 'light,' (absence of dark, to be more precise). As you go deeper and deeper beneath the surface, you will notice that it gets darker and darker. When you reach a depth of approximately fifty feet, you are in total darkness. This is because the heavier dark sinks to the bottom of the lake, making it appear 'lighter' near the surface.

The power companies have learned to use the dark which has settled to the bottom of lakes and rivers by pushing it through turbines, which generates the electricity used to pump

the dark toward the ocean where it may be safely stored for their devious purposes.

Prior to the development of turbines, it was much more difficult to get the dark from the rivers and lakes to the ocean. The Indians recognized this problem, and developed means to assist the flow of dark on its long journey to the ocean. When on a river in a canoe travelling in the same direction as the flow of dark, they paddled slowly, so as not to impede the flow of dark; but when they travelled against the flow of dark, they paddled vigorously to help propel the dark along its way.

Scientists are working feverishly to develop exotic new instrumentation with which to measure the actual speed and energy level of dark. While such instrumentation is beyond the capabilities of the average layman, you can actually perform a test to demonstrate the unbelievable speed of dark, right in your own home.

All that is required for the simple test is a closed desk drawer situated in a bright room. You know from past experience that the tightly shut drawer is FULL of dark. Now, place your hand firmly on the drawer's handle. Quickly yank the drawer open - the dark immediately disappears, demonstrating the blinding speed with which the dark travels to the nearest darksucker!


The secrets of dark are, at present, known only to the power companies. Dark must be very valuable, since they go to such lengths to collect it in vast quantities. By some well-hidden method, more modern power 'generation' facilities have devised methods to hide their collection of dark. The older facilities, however, usually have gargantuan piles of solidified dark in huge fenced-in areas. Visitors to these facilities are told that the huge black piles of material are supplies of coal, but such is NOT the case.

The power companies have long used secret acronyms to disguise their activities. 'D.C.' stands for 'Dark Conspiracy,' while 'A.C.' is suspected to represent the 'Alternate Conspiracy' which will most likely be used exclusively once the secrets of D.C are totally understood. D.C. is rapidly yielding its secrets to the probing eyes and instruments of honest scientists around the world.

The U. S. Attorney General is considering action to be taken against the power companies for the theft and stockpiling of dark from 'consumers.' New developments are being announced every day and we promise to keep the public informed of these announcements as they occur via this newsletter.

From the Rocky Mountain Chapter of Rose Croix

In my mere six years as a member of the Denver Consistory, I have noticed a concerning pattern around the Rose Croix Funeral Service and its implementation. Perhaps you have noticed this as well. Too often, we hear the numerous names read from the Memorial Scroll at each of our meetings. And yet, for all the names read, a very small percentage actually receive the Rose Croix Funeral Service. This service is one of the most profound of the few rituals that can be performed in a public setting, serves to honor our fallen Brethren with a final tribute of respect and love. It openly celebrates the individual's deep connection to the brotherhood, its rigorous work, and commitment to supporting the man's strong values. It exemplifies and celebrates the true, lasting, and inherent value of the Masonic journey. It serves as a most profound ritualistic send-off of love, honor, and respect to the deceased by the Masonic community, but also as an opportunity to show others what it truly means to be a Mason.

The question remains then ... WHY? Why are so many Brethren passing on to the Celestial Lodge above without requesting or receiving the Rose Croix Funeral Service to which they are entitled? The full answer may never be known, but I'm sure we can all posit some theories. I know I have a few. I'm sure some are no longer residing in the area. Certainly, a fair point. Perhaps some others just aren't as active anymore and haven't really considered it as an option. For others, their families may not be as supportive of the fraternity and don't want any masonic service included in the regular funeral or memorial service. Or, maybe the Brother himself doesn't want it. And, I'm sure that all of you who have participated in Masonic funerals before have encountered the resistance that comes from a few of the churches and clergy in the area. These are all viable possibilities.

However, I'm guessing a far more likely scenario is that, in many cases, the family doesn't even know to request the service. That information was never conveyed orally by the Brother to his family, or most likely, never written down formally. It's one thing to tell your spouse or family that the service is something you desire and quite another to have it written down with clear contact information and instructions so they can follow up when they are in a time of intense grief. Can you imagine going through the death of your spouse, father, brother, son, and on top of all that all the other arrangements to be made, trying to figure out who to contact from some organization of which you've never been a part? That, of course, implies that you know that you are supposed to contact that organization. Some aren't even aware that they should reach out to inform the Lodge or Consistory about a Brother's passing until the next dues notice comes in the mail.

For that reason, over the next few months, I will be rolling out a campaign to promote the Continued on next page

Rose Croix service through announcements, emails, and postcards to every single member providing a quick, simple method to inform the Consistory of your desire for the Rose Croix service (or not). Each member who participates will be provided with a printable or downloadable page that can be filed with your final paperwork outlining contact information and clear instructions for your family to follow upon your passing. Be on the lookout. Once the information is sent, I urge all members to take just a few minutes of your time, fill out the online form, and secure your right to receive the Rose Croix Funeral Service. Most importantly, make sure your family has all the information they need to make it happen. This is your right, and our obligation.



We are in the season of lent, which is important to Christians. It lasts for 40 days, excluding Sundays, and it marks the time Jesus spent in the wilderness. It ends on the Saturday before Easter. PART OF A BALANCED DIET

Remember the cereal commercials that ran during Saturday morning cartoons when you were a kid?

The advertisers informed us, following the pitch to have Mom procure their wonderful (typically sugar-laden) product on her next trip to the market, that what was in that box was "part of a complete breakfast." There'd be a quick pan across the breakfast table, where we'd catch a glimpse of the orange juice and toast alongside the cereal bowl. Well, okay: carbs + carbs + carbs + milk and maybe butter to include dairy + a nod to fruits and veggies with the juice (though usually with "sugar added" in those days).

"Complete?" Well, perhaps as in "That's all you're getting until lunch!" ... sort of a truncated "food pyramid" actually! But, we managed and even thrived, as we began the day with something likely short of a "balanced" meal. Most of the carbs probably got burned off by noon anyway!

So, I was thinking about that idea of a balanced diet, after our recent Master Craftsman session. Yes, I know: here goes Bill's runaway mind again ... but, seriously, I was!

It was a good session. Well attended, by recent standards, with a discussion on a topic from the Symbolic Lodge course, fellowship, participation, and over before it became tedious (I hope!). In my estimation, a fruitful meeting ... but only "part of a balanced diet," in terms of Masonic education.

I like Master Craftsman. I enjoy promoting it, helping with enrollment, and advising on the procurement of materials. I even find it satisfying to assist with problems that arise (especially when they're solved), though I'd maybe stop short of "enjoy" on that one. The program is a hugely helpful, dynamic offering by Supreme Council for all Masons, and **ALL** Masons ought seriously to consider making a commitment to complete the courses.

But, considering the broad possibilities of our "university of Freemasonry," Master Craftsman is only the "core curriculum" ... well, maybe a baccalaureate degree ... but certainly not a PhD! "Graduate Programs" are largely something we must assemble and execute for ourselves, although there is assistance available. Consider ...

BOOKS

There is a very serviceable recommended reading list, assembled by Arturo de Hoyos, 33° GC, KYCH, in the back of *Scottish Rite Ritual Monitor & Guide*. That list can also be accessed on the Supreme Council website:

If you're in your Blue Lodge line, try The Master's Book. Looking for inspiration? Maybe Contemplative Freemasonry or 365 Level Steps. Masonic history & current events? Perhaps Recognizing Prince *Hall.* The Kindle app is free and there's a version for tablets, smartphones & desktops.

PERIODICALS

There are not so many Masonic-themed "magazines" as one might expect, but there are some good ones ... and some not-so-much; be discerning! In addition to publications of research societies (see below), two places to start are, of course ...

- 1. Our very own *The Scottish Rite Journal* has worthwhile articles & features in every issue.
- 2. Rocky Mountain Mason is a quarterly publication "...containing articles of interest to Freemasons in general as well as Masonic history, philosophy, esoterica, and current events." RMM also has a *podcast* (live every Wednesday), also available via Apple Podcast, Google Podcasts, or Spotify.

RESEARCH LODGES

Just about every Masonic Jurisdiction has a research lodge. Some are more active than others, but most promote the production of scholarly papers and essays on Masonic topics, and they are typically open to membership by Masons outside their jurisdictions. *Research Lodge* of Colorado is a chartered Lodge (#999), under the jurisdiction of the MW Grand Lodge of Colorado, and has recently published Transactions, vol. 1 (papers presented before the Grand Lodge 1953-1959). Their quarterly newsletter is *Lucerna*.

RESEARCH SOCIETIES

There are a number of excellent organizations dedicated to discussion and scholarly work on Masonic topics & themes ... and a few not-so-excellent ones too, so be circumspect. A few of the better known are ...

The Masonic Society has as its stated purpose, "... to foster the intellectual, spiritual and social growth of the modern Masonic fraternity." The Journal is an excellent quarterly publication, and the website's Forum (for members) is a great place to find discussion of Masonic subjects.

<u>Philalethes Society</u> is "devoted to the promotion of the highest quality masonic education and research. Its major publication, **Philalethes: The Journal of Masonic Research & Letters**, has long served as the de facto magazine for North American Freemasonry.

<u>Scottish Rite Research Society</u> is a scholarly adjunct to our own Supreme Council, S.J., and a membership subscription may be had from its Online Store: <u>https://www.scottishritestore.org/</u> the same place, BTW, where you can purchase *Master Craftsman!* The SRRS publishes *The Plumbline* (its quarterly bulletin) and *Heredom*, (a volume of its annual transactions). Both of the publications, along with an annual "surprise" book and a discount on many Supreme Council publications, are included with membership.

BLOGS & PODCASTS

In addition to The Masonic Society's **Forum** and Research Lodge of Colorado's weekly blog, you might want to check out Supreme Council's <u>Tyler's Place podcast</u> (this one from August of 2020), Chris Hodapp's <u>Freemasons for Dummies</u> blogspot, or the virtual fellowship and education sessions coming soon from our own MW Grand Lodge of Colorado. Watch for updates on when the latter will begin, slated for the 3rd Thursday of each month.

TV & MOVIES

Secret Societies on **The History Channel** anyone? Uh, ... no thanks! Films based on Dan Brown's novels? No ... well ... not as Masonic education! Unfortunately, I'm aware of nothing worthy, of a dramatic nature ... nothing on par with *Downton Abbey* anyway. But, for documentary devotees ...

Inside the Freemasons, a 2017 project of Netflix, is a five-part series that focuses on Masonry "across the pond" follows candidates progressing through the Craft Degrees and features some info on how Masonry operates under the United Grand Lodge of England. There's some interesting perspective on Masonic involvement in England too!

Terra Masonica: Around the World in 80 Lodges (2017 by Nexus Factory on DVD) was the creation of producer Tristan Bourlard for the tricentenary of modern Freemasonry. It is literally a trip around the "Masonic World" and dishes out a healthy sample of the variety (if not nearly the entirety) of our global Fraternity. Last I checked, it is "out of print," though you may find it available for streaming. If you can locate a copy, the two hours' viewing time is well spent.

I hope that's helpful and serves as a hint of what's out there to be gathered, gleaned, plucked and mined to enrich our Masonic travels. In coming months, I'll try to present something you might enjoy along the way in your own journey.

MEMBER SPOTLIGHT



Illustrious Brother John A. Moreno, 33°

"Do you wish to proceed?" Do you wish to proceed?"

We have all been asked that question. Each one of us as we have received the 30th Degree has been asked that very question by the Preceptor—the Plague Doctor. As well, we have each heard Moses give us the Ten Commandments in the 14th Degree. And, I believe every one of us has had our picture taken on several occasions by Moses, or the Preceptor, or the Brother that is the subject of this month's Member Spotlight - III. Brother John Moreno.

It has been a real pleasure to know and to work with Brother John for the past few years and I really enjoyed our time together during the several hours that we spent on the phone last week preparing this article. He is certainly one of the most interesting people I have ever met—and fun to talk with! One of the first things John said to me when we began our conversation was that he **always wanted to be a principled and good man.** His success in achieving this goal became more and more apparent as we talked.

III. Brother John was born at Presbyterian Hospital in Denver on March 25, 1947. (Hint: his birthday is coming up soon!) John graduated from Wheat Ridge High School after being raised by his single mother. He scored very high on an IQ test, but was put in a remedial reading class basically because he was bored. John wanted to be a mineralogist and had a rock collection weighing more than 300 pounds that moved with him and his mother as they moved around in the western part of the Denver suburbs and up into the mountains. John's uncle Paul had been a "powder monkey," or dynamite specialist when the tunnels were being built in Clear Creek Canyon. When John and his mother lived in Jamestown a local mineralogist took John under his wing and between that man and his Uncle Paul, John's love for rocks grew and he wanted to attend the Colorado School of Mines in Golden after high school. However, John had a serious "boogey man" to overcome. He struggled mightily with mathematics, specifically geometry, and his career as a rock man was not to be.

Luckily, another uncle, Tony Shearer was an artist and began teaching John to draw and sculpt. By the time he was in the 3rdgrade, John was drawing in perspective, meaning in 3-dimensions. He turned his interest towards the arts in high school—specifically sculpting, drawing, and painting. John had obtained his first camera when he was about seven years old and photography was a natural extension of his interest in the arts and he began taking many, many photographs. His mother also encouraged John to take drama classes to help him overcome his introverted nature and shyness. He developed as an accomplished actor, but with "no rhythm," he was not to become a dancer. He was accepted for admission to the Royal Academy of Dramatic Arts in London, but unfortunately was unable to attend because his mother developed serious cancer issues and at the same time some mental health issues. John chose to stay and care for his mother.

Because of his superb acting skills, John received a full-ride scholarship to the Denver Academy of Dramatic Arts. During his three years there, he built a strong reputation as an actor, often appearing in productions at the Bonfils Theater—the forerunner to the Denver Center for the Performing Arts—and in the period from 1965-73, he became the "Toast of the Town." In addition to his dramatic acting roles, John also worked as a newspaper copy boy, a dental technician, a plastic fabricator, and as a precision sheet metal fabricator. Truly a man of many talents. In 1968, John married his first wife and they had two daughters - Anastasia and Desiree, both of whom still live in Arvada.

Let's go to John's **desire to be a principled and good man** for a moment. John had been playing opposite Morgan Fairchild (yes, THAT Morgan Fairchild!) in Neil Simon's **Plaza Suite** at the Country Dinner Playhouse on Arapahoe road, just off I-25. They were a great pair and often went "off script" and ad-libbed their lines very successfully. John was also working tech regularly at the old Taylor's Supper Club in Lakewood about this time.

In 1973, John and Morgan got a contract for a new television series - probably "My Favorite Alien," although they never were given the name of the series. Their Denver talent agent told them that they were "too big" for him to handle and that they needed an agent from Hollywood or New York. The new agent came to town, John and his ex-wife had dinner with the new agent, and they discussed the future. John's impression of the man was that the agent was rude, impolite, and not pleasant to spend the evening with having dinner. The next day, the agent called John to tell him to "get rid of the wife." The agent would arrange all the details for the media to begin to recognize and identify John and Morgan as "a thing." At that point, John asked himself if he was an artist or a commodity? We all know how he answered, and his decision was to NOT divorce his wife, to break the contract and to remain in Denver, performing in community theater. Unfortunately, because of his honesty, integrity, and scruples, John was "blackballed" in the theater business, and his career as a paid actor was essentially finished. Note that I said "paid actor." We are still treated to his wonderful and outstanding performances as a volunteer actor in the 14th and 30th Degrees. And, he and his first wife did divorce, but not because of his acting career.

Now, to another part of Brother John's story. He became interested in occultism, spiritualism, and religion because of being around several influential native Americans as he was growing up. Flying Horse, a Lakota Sioux elder, became like a grandfather to John. In high school, John began reading Tarot cards—the Book of Toth. Uncle Tony—the artist—also greatly influenced John in these areas. Tony spent many years in Mezzo-America after leaving home at seven years old to become a lumberjack. Uncle Tony was instrumental in unlocking the key to the Aztec calendar.

John had become a prolific Tarot card reader, primarily at the Sign of the Tarot Coffee House, using the Waite-Rider pictorial deck. The Book of Tarot goes back to ancient Egyptian times. In 1983, John unfortunately predicted a death in a Tarot card reading and that death came to be shortly after. John has not done Tarot readings since that unfortunate incident.

While working as a precision sheet metal machinist in 1973, John had the opportunity to buy a Nikon F2 camera with a Nikkor lens for \$125. A great bargain, but a huge investment for a newly divorced man with two daughters. John took the leap, though, and bought the

camera. The camera became a part of our basically introverted Brother and he started taking hundreds and thousands of photos. Mainly nature and landscape photos and not people. He had always been a hiker and took many photos near Charm Springs on Bald Mountain in Clear Creek Canyon. Charm Springs is a sacred spring and is John's spiritual center that he always returns to when he needs to be re-energized. A family friend of John's, a descendant of General George Armstrong Custer, owned land on Mount Vernon, near the Beaver Brook Trail leading to Charm Springs.

On one of his many hikes to Charm Springs, John took some photos of his daughters. They were fantastic! Friends began asking him to photograph them, their families, their weddings, and other special events. Lost Image Photography was born in 1975. The name Lost Image Photography comes from John's statement that "every picture not taken is a lost image." John became a full-time photographer in about 1980 after suffering a severe back injury at work in 1979. Being divorced, he had bought a home in Edgewater with his mother. After an industrial accident, he was off work for nearly two years and decided then to go into photography full-time. John achieved great success with his photography business and became a well-recognized portrait photographer of note. He ultimately had three photographers working for him.

In 1987, John married the girl next door. He and June have been happily married and business partners for more than 34 years. She ran the business and John took the photos. June has a daughter—Nikki Lester in Colorado Springs and a son - Frank Strunk in Los Angeles. Her other son Kenneth unfortunately passed from leukemia.

June had been active in Edgewater City politics for several years, serving on the Parks & Recreation Board. John had served on two City Charter Commissions and ultimately decided to run for Edgewater City Council. He lost by one vote in that election but continued to stay somewhat active in local politics. After a short while, the woman that won the election resigned because of her move to another area. John was appointed to serve the balance of the term. He became very involved with the Colorado Municipal League (CML), an advocacy group for the state's cities and towns at the state LEGISLATURE. John was very concerned with openness and transparency in local government bodies and was instrumental in drafting and passage of the "Sunshine Law" for local governments as well as rewriting the law governing the Home Rule Charter process. Many less-than-pleasant experiences he had were personal in nature, and as he became more and more disillusioned with some local government officials, he made the decision to resign from the City Council. Again, John's *desire and commitment to be a principled and good man* were evident.

In 1994, Brother John's Masonic journey began. Brother Jim Kelly of Edgewater Lodge #159 carried John's petition and he was initiated, passed, and raised in Edgewater #159. John served as the Worshipful Master of Edgewater #159 in 1999, prior to it merging with Liberty Lodge #134 in 2002. A later merger created New Frontier Lodge #134. Worshipful Brother John's Secretary in 1999 was none other than III. Brother Matt Raia.

John joined the Scottish Rite in 1999 at the urging of Brother Raia. He had served as the 1st ruffian in the 3rd degree and was the candidate in his class for the 18th Degree. He became

the Assistant Director of the 14th Degree, then became Moses In that degree and later the Preceptor in the 30th Degree. Not the "grim Reaper," but someone who is close to death but certainly not dead yet. Think about your own reaction to the 30th Degree. "**Do you wish to proceed?**" Brother John's professionalism as an actor really stands out as he removes his mask, in order to speak frankly with the candidate. And his "*Ring around the Rosie*" and "All fall down" are strong lessons to be studied and learned.

In 2003, John became the "unofficial official" photographer for the Grand Lodge, the Consistory, Band Camp, and numerous other Masonic bodies and activities. He continues in that role today, even though he has closed his business and moved to Colorado Springs. He is a plural member of the Colorado Springs Consistory and Manitou Lodge #68. John is a Past Commander of the Colorado Council of Kadosh and has been very instrumental in the Consistory's Blue Lodge Ambassador Program.

John's advice to his Brother Masons-

- As Worshipful Master, The Lodge is yours. But, only for the year. Carry on the work that began before you and prepare for the future.
- Trust your Secretary. He's the most important person in helping your Lodge to have a good and successful year.
- Masonry is a big world. It's universal. You will learn lessons when the Creator reveals the meaning of symbols. The guidance will be there. Be patient.
- Manage your expectations and govern your actions accordingly.

As you might expect, John's list of most influential men in his Masonic journey reads like a "Who's Who?" of Colorado Masonry:

- Ill. Brother Matt Raia—John's Secretary at Edgewater #159 when John was in the East;
- Vern DuBois, John's poster;
- MWGM Keith Milheim, a Past Master of Edgewater #159;
- Ill. Brother Ron Birely;
- Ill. Brother Steve Munsinger; and
- Ill. Brother Karl Hinkle.

Illustrious Brother John is truly and genuinely an interesting man, and I am so thankful to be able to call him "friend." As you visit with John, you soon realize that his commitment to "do the right thing" is what makes his strength of character so solid. In his own words, he is somewhat introverted, but he is always anxious to share his wisdom and guidance with his Brothers. I urge you to reach out and get to know John better. You will be a better man and Mason from being his friend.


