A Capitol Hill church wants to become a developer — and build homes on its parking lot



First Baptist wants to exceed the city's new, tougher requirements for affordable housing.

The lots next to the historic First Baptist Church of Denver have served many functions.

For years, apartment buildings stood there. Then in the early '60s, the church tore down the apartments to make way for parking. In 2020, the parking lot served as the pilot Safe Outdoors Site, sanctioned camping spots for unhoused residents.

Now, decades after the parking lot was built, church members have decided they want apartments there. They are proposing to develop those same lots into a mix of incomerestricted and market-rate housing. [3461266]

How did the church find itself acting as a developer?

"We have been charging people to park in our lots for the last several years," said the church's minister, Brian Henderson.

Running a parking lot proved to be financially unwise. Taxes kept rising, and the church council decided to look into developing the land instead.

After exploring how to find a developer to buy the property, the church decided to become a developer itself, working in partnership with other companies. That was a first for the congregation, and the past year has been a learning opportunity, said Henderson.

In early September, the church, along with LAI Design Group, filed concept plans with the city for a 12-story 216-unit residential complex to be built at 1335 and 1345 North Grant

Street, near the Colorado Statehouse.

The recently submitted application is one of the first for a large-scale residential project under the new Expanding Housing Affordability rules, which went into effect on July 1.

Expanding Housing Affordability is the plan Mayor Michael Hancock signed into law earlier this year that forces developers to do more to solve the affordable housing crisis by either building income-restricted units or funding them.

While some developers helped draft those rules, many in the business argued they would slow down new construction and make it too expensive to build new apartments and condos in Denver. Advocates, like Drew Hamrick of the Colorado Apartment Association, recently said multi-family residential development proposals have basically stopped.

Yet First Baptist Church's proposed project at 1335 and 1345 Grant Street could be the sign that some developers are pushing forward, enthusiastic about the new rules, and keeping affordability front and center as they proceed.

The church plans to build more than the required amount of income-restricted housing. If 12 stories is approved, 20% of the units will be dedicated to people making 60% of the area median income.

Area median income is currently \$82,100 for a single person or \$105,500 for a family of three.

"Because we're a church, that's an important component for us is to be able to help people," Henderson said.

"This privately funded project will be the first of its kind where 20% or more of the units will be affordable and set the standard for all the work that has occurred with the Expanding Housing Affordability policy," LAI Design Group explained in the application. Here's what the project will look like.

LAI wrote: "The proposed project is a 12-story multi-family residential building that will strive to be energy efficient, produce a reduced carbon footprint, and provide 20% or more affordable dwelling units all within a building that respects key historic features, simplified interpretation of historic design, details of color, texture, and finished materials."

The ground floor would potentially include amenities for residents, retail, restaurants and coworking space. New landscaping, bike racks, sidewalks and ideally a bus stop would line the street.

There would be 121 stackable parking spaces for the structure that would be dug into the ground, pending approval — one of the first of its kind in Denver.

On the roof would be both areas for leisure and solar panels.

The project would be constructed in the Civic Center Landmark Historic District, and while it would be a new building, it would attempt to reflect the aesthetic of the area.

Design mattered to the church, whose members did not want yet another blocky monstrosity.

"Our congregation felt very strongly from the beginning that they did not want a box," said Kenton Kuhn, the church's volunteer property chairman. "Even if they have to spend a little bit more money to make it look like something that fits the neighborhood and something that we can be proud of, that's what we all want to do."

What are the next steps?

The concept plan submitted is generally the first step in any new development and could go through multiple drafts or be entirely shut down by the city.

After the plan was turned in, Denver's planning department, Community Planning and Development, quickly flagged the application to ensure it complied with the rules of the area.

The project will be reviewed by the Landmark Preservation Commission.

If the city approves, the design then has to be fleshed out, permitted and built.

The Wit ... and/or Wisdom ... of Brother Will Rogers

BIG WORDS: "I never try to fog the issue by using any big words in any of my sermons or speeches, no matter what type the audience is," explained Will Rogers. He also preferred to avoid big words, he said, because he didn't know many. "Course with a speech you can use some big words, and it comes in handy sometimes. Your audience will be confused over it and that will give you a chance to think of something. Big words in speeches, you see, are just used for about the same reason as a speaker stopping and taking a drink. He ain't thirsty."


BIRTH CERTIFICATE: When Will Rogers applied for a passport to go abroad in 1926 he stumbled into an unexpected bureaucratic barrier: he had no birth certificate. "You see, in the early days of the Indian Territory where I was born," the Native American wrote to President Coolidge, "there was no such thing as birth certificates. You being there was "certificate" enough. We generally took for granted if you were there, you must have at some time been born. Having a certificate of being born was like wearing a raincoat in the water over a bathing suit." The requirement was waived. The passport was granted.

NATIONAL BUDGET: Congress is eternally debating the national debt, arguing over whether to allocate a few billion (now maybe trillion) here or a few billion there or to spread out a few fewer billion everywhere. Will Rogers felt there was an air of unreality about the whole process of deciding the national budget: "The budget is a mythical beanbag. Congress votes mythical beans into it, and then tries to reach in and pull real beans out." Rogers offered a common-sense solution to the nation's never-ending budgetary crisis: "We will never get anywhere with our finances till we pass a law saying that every time we appropriate something, we got to pass another bill along with it stating where the money is coming from." Political leaders have not been inclined to take Will Rogers' advice, regarding it as impractical.

POLITICAL CANDIDATES: "History has proven that there is nothing in the world as alike as two candidates. They LOOK different till they get in, and then they all act the same," Will observed. "You know it don't take near as good a man to be a candidate as it does to hold the office, that's why we wisely defeat more than we elect."



And Best ... Disagree



"Behold, how good and pleasant it is..."

This month, my housekeeping comments have to do with a recent (August 31) message from Sovereign Grand Commander Jim Cole. If you didn't view the Scottish Rite Statement of Unity event (the live-streamed event he invited us to attend), you can still view it here, via our own Scottish Rite, S.J. posting or as a YouTube posted recording here. I heartily recommend that you carve out the time (only about 24 minutes) to do so.

I found this to be a real "did my heart good" experience, as the four U.S. Grand Commanders took a sincere "next step" in expressing a common mission and purpose for the future of the Rite. Brethren, I hope you'll agree that watching the ceremony—seeing & hearing the passion and commitment in these leaders' messages—represents a moment of pride and hope, in a chaotic & too-divided world. When one considers the history of traditional Grand Lodge-affiliated and Prince Hall Affiliated (PHA) Masonic bodies, seeing these men express common ground and acknowledge the need for closer cooperation is truly inspiring. For me, it is also a sterling example of what can be accomplished when Masons realize how much we can do together. Even when we cannot entirely agree, we can still figure out how to "best disagree," and on that note...

And best...disagree?

At a significant point in his travel through the Third Degree and then throughout our work in Scottish Rite (check out a theme in the 6th Degree, for example), a new Brother has a critical point made to him about Harmony. He learns that he needs to use the skills of his Craft to spread the "cement of Brotherly Love and Affection," and he's reminded not only to encourage harmony within the institution but to take pains to actively discourage dissension: going even so far as to turn our human inclination toward competition into a contest to determine who can be the least contentious!

Imagine! Life as a contest NOT just to determine who can do the best work (a prideful endeavor, even at best) but more so to ascertain who among us is the most cooperative and agreeable worker! What a world that would be to live in!

I happen to believe that competitive endeavor is a great improver and motivator...generally. Life is (and should be) much more about striving for excellence than collecting "participation trophies!" Nevertheless, addressing tasks...solving problems...should bring out the best and not the worst in us.

It is true that competition can bring strife and discord in a community: and the more so when undertaken for its own sake. Add to that a situation in which high standards and expec-

tations are the norm (as should be the case in the Craft), and the negative side of competition may well take over. In the past, I've used this space to explore a bit about the importance of Harmony in our Fraternity, but now I'd like to spend a little ink looking at a particular implication of that concept...and one especially critical in our world today.

The fact is, even within the Craft, that we cannot always avoid dealing with ideas and themes upon which we may disagree. I believe that it is significant that there isn't the emphasis in Scottish Rite—certainly not to the extent that we find in Craft Lodge—on avoiding such topics. Why so? Perhaps it is because, as students in the *University of Freemasonry*, we are expected to have attained a higher level of maturity: one which allows us to deal with such things while still maintaining a harmonious relationship with others.

The "trick," it seems to me (and I must thank Bro. Maynard Edwards for putting me in mind of this in one of his postings), is to be able to find a way to "disagree without being disagreeable."

If that sounds difficult, I can confirm that it certainly can be. However, how can we truly be a place where men come together "who would have otherwise remained at a perpetual distance," if we do not respectfully accommodate the differences our Brethren bring with them through the West Gate? The Fraternity is not intended to be a place where only those who already agree on everything are welcome! That is not what is meant by "harmony." Nor is harmony the glossing over of differences or (just as destructive) a demand for some sort of enforced acceptance of a single point of view. Indeed, both of those unacceptable options are a fair summation of what has landed modern society in the divided mess we often see today!

We seem to have ended up at a point where there is no longer an interest in civil discourse. But, in a society based upon democratic institutions—institutions that no one had more a part in creating than Freemasons, there are really only two alternatives to civility and creative compromise: either a single point of view comes to totally control the debate...and tyranny results...or complete gridlock prevails, and the society stagnates and devolves into warring factions.

What have we to offer: we who played such a role in creating these noble and flawed experiments: America and the Masonic Fraternity? It seems to me that we are the ones who still have the primary responsibility to steer both through the rough seas that each is currently facing. We, regardless of our own doubts and flaws, are still those with the clearest vision of what human beings can accomplish, when we find a way to lay aside superficial differences and concentrate on the important things.

That comment brings me full circle to my thoughts on the signing of the Statement of Unity. The four Supreme Councils have periodically engaged in, let's just say, some "considerably less than Brotherly" rhetoric directed at one another. And yet, with patience, forbearance and goodwill, they arrived at a level of agreement that reaches even beyond mere amity, and which bodes well for the future of the Rite.

And so, Brothers, it comes down (as it always does) to the issue of whether we are willing to be true to the tenets of our profession, putting the principles we espouse "in theory" into practice "where the rubber meets the road." Four Supreme Commanders managed to find that common ground and publicly declare it to the entirety of Scottish Rite Masonry. They

were motivated by necessity, by a love for the Fraternity, and, ultimately, by respect for one another. Isn't that the key, really?

It simply isn't possible to always agree, when it comes to "dotting all the i's and crossing all the t's" on every issue. But we've all probably had the experience of disagreeing with someone and coming out of the encounter with a realization of how little substance there really was to the disagreement! To disagree, without the need to be disagreeable, is a talent worth the time, effort, and energy to cultivate, and it is a skill that goes further to promote harmony than about any other. It takes two willing parties, ultimately, to "agree to disagree," but I would venture to say that the harmony so achieved is worth as much (and often much more) than that among those who already saw eye to eye on things.

When it's all said and done, the real test of harmony isn't how well we get along with those with whom we already agree. Rather, the ultimate test of this core Masonic principle is whether we can find common ground and even make common cause with those whose opinions differ from our own...and find a way to "best disagree."

V.M.A.P. is essentially a working checklist for Valleys to use to make sure that all aspects of Scottish Rite requirements are broken into the following 6 specific subject areas which cover the full scope of the Scottish Rite experience:

Membership Retention & Engagement Member Restoration & Reinstatement Membership Recruitment Reunion Experience

That "working checklist" part is of primary importance, because rather than making V.M.A.P. a static, after -the-fact assessment of "what we've done," it is a program through which we may constantly judge "how we're doing," in terms of what we offer our members and how we provide for the future of the institution. The experience that our members have, in their participation in the Rite and in the activities of the Valley, is absolutely the most important factor in determining their continued participation and, therefore, the growth of the Rite.


