LEADERSHIP—Part 1

The Beacon of a Prestigious Organization

In 2004, our late Brother Randy Trullinger, 32° KCCH, and I developed a Leadership presentation for a gathering of Job's Daughters adults from around the country. We used materials from many sources, including a Leadership presentation by Coley Dize, a nationally known lecturer, on "Coyote Thinking—Surviving in a Hostile Environment." The principles we presented then are just as valid today and apply to ANY organization whether it be Masonic or otherwise.

FACT: Less than 50% of all "followers" TRUST their leaders. Lack of trust in leaders is across ALL sectors—religious, political, business, etc. The 50% figure is from David Cottrell—Cornerstone Leadership Institute from a presentation to Titan Corporation (one of my former employers, by the way) on Leadership and Employee Coaching in 2004. 20 years hasn't change the numbers all that much. If anything, it may well have gotten worse.

FACT: People quit people before they quit organizations.

FACT: Reasons for decisions are rarely understood (lack of true communications) Not understanding the reasons behind decisions is a SYMPTOM of the "Mahogany Row" mentality—they vs. us. "Management" needs to get in touch with the rest of the world.

WHAT WE HAVE IS A FAILURE TO COMMUNICATE...

1. They don't know **WHAT** they are supposed to do. We don't tell them what they are expected to do. We **ASSUME** (which makes an "ASS out of U and ME") that they already know what to do.
2. They don't know **HOW** to do it. [3643160] Sometimes they do it the way they **THINK** it should be done, not knowing there may be a better or perhaps easier way.
3. They don't know **WHY** they should do it. Sometimes it's tradition, sometimes it's legal bookkeeping to stay out of trouble, and sometimes it's just the right thing to do.
4. They **BELIEVE** they are doing it. Unless they are shown what they are doing wrong or what they are not doing, how can we expect them to know they aren't doing the job?

In a truly Prestigious Organization there are Managers AND Leaders. They are rarely the same person. So, why do you need both in an organization? People and Things. These require different skill sets—similar, but markedly different in how to implement and the results you can expect. Managers deal with things. Leaders deal with people.

You may be good ... but you're not THAT good. Sometimes you just HAVE to be both kinds of person—but never at the same time (virtually impossible anyway). Usually you will be better (more effective) at one role or the other. Knowing the strengths of each person and using them in the best way FOR THE ORGANIZATION, not the individual, is what will make or break a prestigious organization. Example: Not everyone is intended to be or should be a Worshipful Master.

So ... WHO ARE YOUR REAL LEADERS?

To “lead” effectively, you must CLEARLY AND CONCISELY COMMUNICATE your objective to others and then influence them to attain that objective. When you apply “influence” in a friendly way, we call that “leadership” - or, the art of getting others to do what you want them to do, when you want it done, and to your standards.

Like ANY subject, leadership can be TAUGHT. Most people have different levels of innate (natural) abilities as a leader.

Dr. Henry Kissinger once defined a leader as “An individual who created an alchemy of vision that moved people from where they were to places that they have never been before.” Does that definition leave you a little cold?

Coley Dize (a Nationally known leadership speaker) simplified it a little more: **“A leader is someone you choose to follow to a place you will not go by yourself.”**

Now, what is the difference between a manager and a leader? After all, if you can't be effective as both and you can't be both at the same time, there MUST be something different.

Have you ever noticed that people TEND to use the words “leader” and “manager” interchangeably? You saw what a “leader” is above.

Managers—like leaders—are NOT born. They are TRAINED to do what they do. And, like leaders, most people have different innate abilities as managers.

A manager runs a business, institution, or organization. To be effective, they must focus their attention on the problem at hand and be able to change quickly to address the next problem. Management of CHAOS [11142030] has become an accepted way of doing business today—to the point of establishing rewards for those who thrive on chaos. To be an EFFECTIVE manager requires TRAINING—the kind needed to control and calm the mind to think clearly in chaotic situations.

“Dumping” is delegating unpleasant tasks that YOU DON'T WANT TO DO. Usually, this involves an abuse of power—because the person receiving the dump doesn't want to do it either.

“Delegation” is giving away something you don't mind doing yourself, giving them the AUTHORITY to get it done, and HOLDING THEM ACCOUNTABLE.

Why is "influence" so important? Because both managers and leaders bring about changes in relationships with members of their group. You're "up there" - they're "below you"; they "report to you" - you're "in charge"; that's why you get paid the "Big Bucks."

Most group members AT FIRST view leaders as probably controllers and dominators (managers) and that's the way they'll respond even though the leader may have no intention of using power and authority in that way.

How do you know when this is happening? Resistance. Defiance. Rebellion. Negativism. Resentment. Anger. Hostility. Ridiculing authority figures. Blaming others. Forming alliances against authority. Fear of trying something new. [9859950] All these are primary indicators of misuse of power and position over others, and possibly misunderstanding a leader's motives.

According to a study of 1300 executives, out of 16 traits, INTEGRITY was considered the ESSENTIAL leadership trait (Do the Right THING).

The Manager vs. the Leader

A MANAGER

- Administers
- Is a Copy
- Maintains
- Focuses on THINGS
- Dumps
- Controls
- Has a short range view (bottom line)
- Asks HOW & WHEN
- Eye on the detail
- Accepts the Status Quo
- DOES THINGS RIGHT

A LEADER

- * Innovates
- * Is unique
- * Develops
- * Focuses on PEOPLE
- * Delegates
- * Inspires trust
- * Has a long range view (big picture)
- * Asks WHAT and WHY
- * Eye on the bigger picture
- * Challenges the Status Quo
- * DOES THE RIGHT THING

Think about the difference between "doing things right" (by the book) and "doing the right thing" (by the mind and heart).

It is NOT that "managers" aren't important, it's just that we tend to have a LOT of them compared to relatively few real "leaders."

So, we need to find meaningful roles in the organization that reflect our desire to actually be a prestigious organization while not threatening the current occupants of those jobs. When you've been at the TOP of an organization, anything else is a "step down" which is why you see so many disengaged PWM's. Once you've been there, your choice is only between doing it again or not doing it at all.

BUT ... this is a LEADERSHIP LESSON - all organizations NEED experienced leaders to mentor and teach the next generation, which means letting that generation take the wheel and drive the car for a while. Mistakes WILL be made—but usually nothing that can't be fixed.

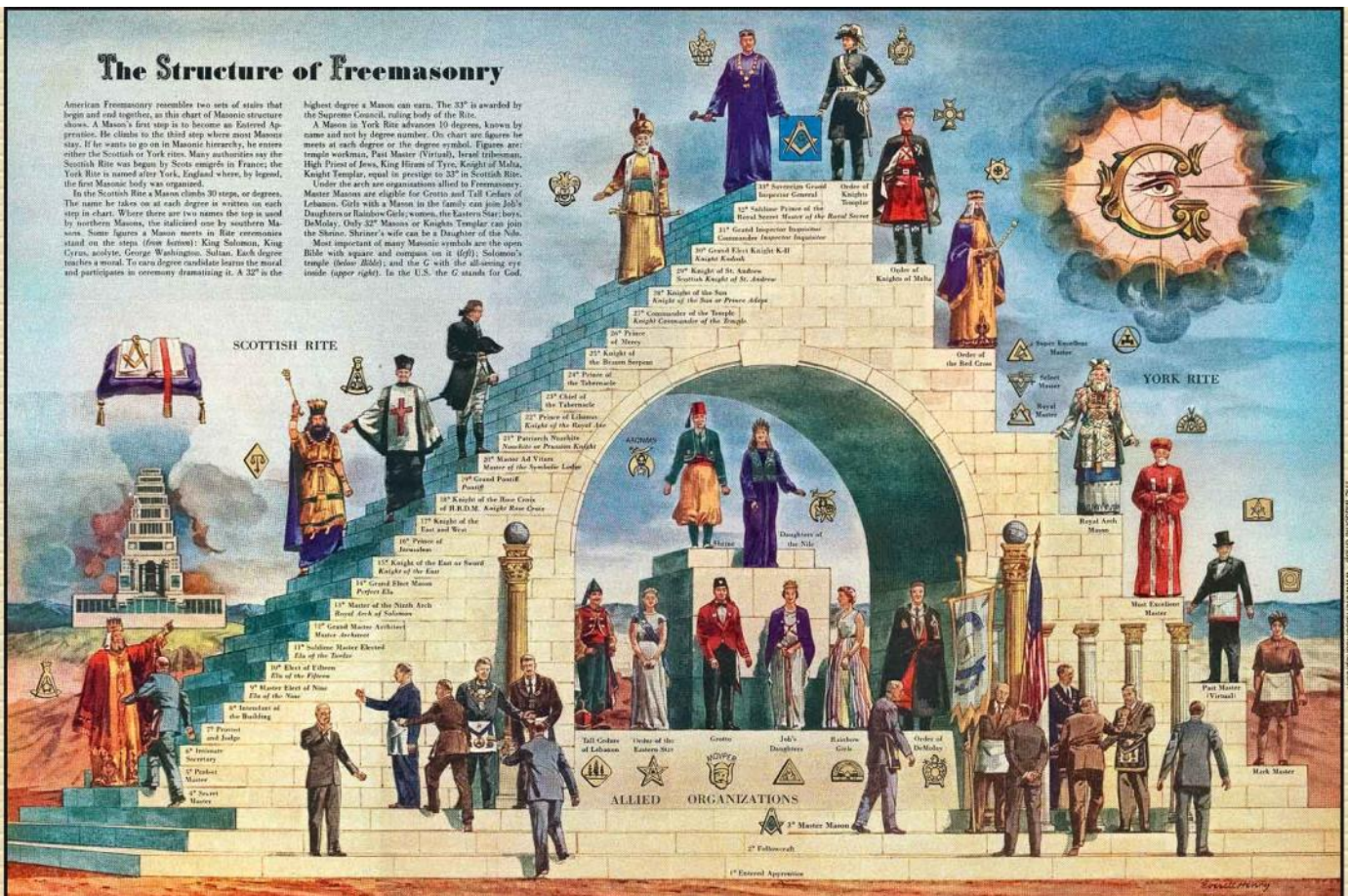

Spain

The earliest Masonic presence in Spain was in the form of English expatriate bodies warranted by the Grand Lodge of England: one styled La Matritense or Las Tres Flores de Lys, in February 1728 in Madrid, and another slightly later the same year, Lodge St. John of Jerusalem, in Gibraltar. Gibraltar was already under British colonial control and the latter Lodge was a military Lodge. A Provisional Grand Lodge of Andalusia (Gibraltar and adjacent area) formed Lodges throughout southern Spain.

The Spanish monarchy cooperated closely with the Spanish Inquisition in discouraging membership by Spanish nationals, so the Fraternity consisted for many years of mostly these English (and some French) expats. A few Spanish Lodges were formed, but members were both persecuted and prosecuted under the authority of both Papal bulls and the decree of Fernando VI banning Freemasonry entirely. One Lodge in Barcelona was denounced not once but twice to the Inquisition. Founded in 1748, it was closed in 1750, reorganized in 1776, and then stamped out again (and all its leaders arrested).

Spanish Freemasonry declared itself independent of England, with the 1767 formation of the Gran Logia Española (renamed the Gran Oriente Española in 1780). "What a difference a few years makes" was an apt description at this point in the life of the Spanish Craft. The first GM of the Spanish Grand Lodge was the Prime Minister of King Charles III, and many of the King's ministers were known to have been Freemasons! By 1800, the Gran Oriente had 400 constituent Lodges. [10583665]

Success always breeds suspicion, especially in a society predisposed to distrust, and by 1738 another Papal bull and royal edict brought on denunciations, trials, excommunication, and fines. It was perilous to be a member of the Craft in Spain, with one's prosperity, reputation, and liberty at stake, depending upon shifting political, religious, and cultural breezes. The 19th century brought cycles of repression, tacit acceptance, persecution, and amnesty.

As one might expect, as Spanish rule over its empire became increasingly precarious, the Lodge became a popular voice and outlet for frustrated colonial populations. That was especially true in Cuba, as a movement for independence grew there: much as had been the case in the early 19th century when so many of the Latin American revolutionary leaders were Freemasons. Spain itself enjoyed a brief respite from monarchical and authoritarian rule, during "six years of democracy" (1868-74), and the Lodge briefly flourished in that environment. This period offers fascinating possibilities for Masonic research and writing: especially for one fluent enough in the language to use primary sources.

It should come as no surprise that an organization suppressed by political forces, in its early history, should, when the suppression is relaxed, be tempted to become increasingly political in the effort to protect itself. This was certainly the case for Freemasonry during a period of more liberal treatment. Naturally, this effort also spawned further suspicion (Sometimes you “just can’t win for losing,” right?). While the Gran Oriente, during this time, found it possible to publish and to promote the Fraternity, it also found itself faced, on the one hand, with an increasing membership bent on using the Lodge to foster political and commercial influence and, on the other, with a rising tide of anti-Masonic sentiment.

The “six years” and the quarter-century Bourbon Restoration that followed represented a sort of “Golden Age” of Spanish Freemasonry ... though not without signs of the continuous tension that always lurks in the shadows of the Spanish Masonic experience. As the 19th century ended, heightened opposition from the church (Leo XIII’s *Humanum Genus* encyclical in 1884) and reaction to a secular movement supported by the Lodge again painted the Fraternity as a threat to traditional culture. By 1899, one fundamentalist cleric opined that ...

Masonry is a monster who conspires in the Caverns of Adoniram to commit all kinds of felonys [sic] and crimes; is the Deus ex Machina of all murders, poisonings, regicides, persecutions against the Altar, the Throne and Fatherland, wars, political crises, slander, revenge, sacrileges, mysteries of iniquity, worship of Lucifer and Palladio, and also of the more horrible mysterious, diabolical, criminal and nefarious occurrences which have happened and are happening in the world...

The Lodge did itself no favors, during this time, by collaborating with independence elements in the Spanish colonies. As the “golden age” ended, the headquarters of both the Gran Oriente and the rival National Grand Orient of Spain were closed by police edict, their document archives confiscated, and some leaders arrested.

Continued accusations of conspiracy and political disloyalty—as well as the actual efforts to suppress the Craft’s activities—resulted in real extremists being attracted to the Lodge. The Fraternity was, after all, a voice for less authoritarian rule and for political and social reform. [11157089] In the wave of radical activity sweeping Europe in the decade-plus before WWI (and then in the interwar period), Spanish Freemasonry hosted its share of socialist, anarchist, and nihilist elements. The Lodge enjoyed a brief surge in popularity during the short-lived Second Republic (1931-36), but this only provided a brief respite before the brutal suppression of the Fascist Era.

Following the Spanish Civil War and until Francisco Franco’s death in 1975, Freemasonry was brutally suppressed—mirroring the experience of the Lodge in Fascist Italy, Nazi Germany, and in areas dominated by fascism. In 1940, the dictator enacted the *Law for the Suppression of Freemasonry and Communism*, with a “Special Tribunal” acting as its judicial arm until 1963. Just in the immediate post-Civil War period, an estimated 10,000 Spaniards were shot ... simply for the “crime” of being Freemasons! Official Spanish Freemasonry totally became an entity in exile, with the Grand Orient of France (which itself was the object of Nazi-occupied and influenced oppression) playing fraternal host to the Spanish Lodge. For four decades—until a decision of Spain’s Court of Administrative Decision of the High Court (May 1979)—the Lodge was a totally illegal organization. Its Lodge buildings and charitable institutions were confiscated and often destroyed.

Today the Fraternity in Spain is “a plurality of different interpretations of Masonic regularity, with the result that one may find there many different types of lodges: liberal, conservative, traditional, secular, deistic, esoteric, regional, national, international, as well as male, female and mixed.” [WHEW! Remember what I said last month about being careful when visiting Lodges outside the U.S.?] The Grand Lodge of Spain (founded in 1982) is recognized by U.G.L.E. and by most U.S. GLs, with the greatest number of constituent Lodges under its jurisdiction.

Last Month’s Trivia Question: Unfortunately, the P2 scandal in Italy was not the first time that the Lodge was implicated in criminal collaboration in that country. Can you discover when that earlier scandal occurred and describe the details?

Answer: In the early 1950s, it seems that several Italian Masonic Lodges decided to take a tip from La Cosa Nostra and enhance their authority, if not their fraternal credibility, by engaging in a variety of shady and even outright criminal enterprises. In Sicily, in 1953, a Mafia boss pressured local Lodges (In all fairness, it isn’t clear—or, at least, I was unable to discover—how willingly they cooperated.) to expel regular Masons and admit Sicilian members of local crime families, as a way of converting legitimate Lodges into criminal entities. The Lodges then used their influence in the community to assist Mafia criminal enterprises. For a time, Sicilian Lodges collaborated in a “code of silence” to stymie police or judicial investigations, except in cases where evidence against Lodge members and Lodge organizations was overwhelming.

This Month’s Trivia Question (Answer in next *Rite Works*): Why did the 1824-25 American tour of Brother Gilbert du Motier, Marquis de Lafayette very nearly not happen?

The Lodge of Promulgation - The Moderns’ negotiating committee had been formed in 1809 as the Lodge of Promulgation, which lasted until 1811. Its original object was to report on the differences of ritual as practiced by Antients and Moderns. Ceremonies were rehearsed in front of the Duke of Sussex (not Harry!), Master of the Lodge of Antiquity (who was to succeed the Prince of Wales as Grand Master in 1813 and was easily the most cultured of the sons of King George III), and the Masters of eight other London lodges.

In the result the working adopted was mainly that of the Antients, notably in the use of Deacons, which had hitherto been confined to Antient lodges, and in the Installation ceremony for Masters of lodges; it is considered that the expression “Board of Installed Masters” dates from that time.

Among other recommendations of the lodge to the Earl of Moira was one for appointing a ‘Professor of the Art and Mystery of Speculative Freemasonry,’ to settle all doubtful points. Such an officer never materialized.



Member in the Spotlight

The only constant in life is change. Well, the Consistory office is undergoing a major change on June 28th – that’s the day one of the familiar faces of the Consistory office, Illustrious Brother Tommy Thompson, 33°, retires from the Consistory after 17 years of service.

Illustrious Brother Tommy grew up in Oklahoma, where his father worked for Chevron. He told me he comes from a Masonic family; his father, grandfather, and great-grandfather were all Masons, and he joined DeMolay at age 17. During his senior year of high school, Chevron closed the Oklahoma office and his father moved the family to Denver. He finished high school while living with his grandmother then moved to Denver to be close to his family.

He enrolled in CU in the electrical engineering program, but says he ran out of money after two years. It was an easy decision to join the Air Force, where he spent six years on active duty with an end goal of going back to college using his GI Bill benefits. He returned home to Denver in 1980 only to find that CU’s engineering program now had a multi-year wait. So he signed up for the Air Force reserves, re-enrolled in CU with his major changed to Computer Science, and finished his degree. He hadn’t forgotten about Masonry, and was raised in Weston Lodge No. 22 in December of 1983. In 1987, he joined the Scottish Rite, then became a Royal Arch Mason in 1998 and both a Cryptic Mason and Knight Templar in 2000.

Everything came together when Illustrious Brother Tommy landed a job with contractor TRW in their Space and Defense Center, working at Buckley ANG Base (now Buckley Space Force Base). He transferred from the Air Force reserve to the Colorado Air National Guard, ultimately serving a total of 21 years between active duty, reserve, and National Guard doing wideband communications.

The military, however, has a funny way of showing its appreciation for those with special skills. In 2003, he was recalled by the Air National Guard and sent to what he wryly referred to as “sensitive places,” not elaborating further. [11158629] I seem to recall that in March of 2003 the United States led the invasion of the Republic of Iraq, and can only infer that at least one of those “sensitive places” was very likely hot and sandy.

A year and a half later, Illustrious Brother Tommy returned home. Shortly after that, TRW was acquired by Northrop-Grumman who laid off all Denver-based employees. That gave him the time to pursue Masonry. He began attending and affiliated with Jacques DeMolay Lodge No. 171, eventually going through the chairs and serving as Worshipful Master. He remains a member of Weston Lodge, and has also affiliated with Black Hawk Lodge No. 11.

In 2004, Illustrious Brother Tommy began volunteering in the Consistory office, which led

him to begin a full-time job in the office in 2007. Two years later, he received his red hat, and then his white hat in 2013. He told me a story about himself about being a newer Scottish Rite Mason. Denver was hosting a regional event to confer all the degrees with degree teams visiting from a number of states, and Illustrious Brother Tommy was tiling. A visitor wearing a purple hat walked in, and true to his job, Tommy asked the visitor for his dues card. The stranger, who was the Supreme Grand Commander, asked “Do you know who I am?” He was told “Yes, you’re the guy in the picture hanging on the wall, but I still need to see your dues card.” Illustrious Brother Tommy laughed and told me he was sure that was the end of his Scottish Rite career. But a few weeks later a letter arrived from the Supreme Council praising him for doing his duty.

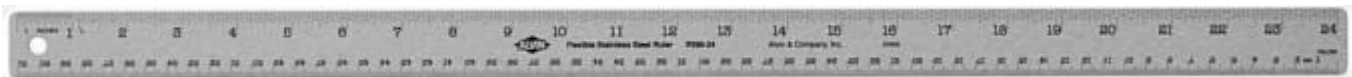
In 2014 he was Wise Master of the Rose Croix line, and has been in numerous degrees over the years. He was no less busy in the York Rite, serving as Excellent High Priest and as Eminent Commander in 2011, then as Thrice Illustrious Master in 2012. That same year, MIGM Jerry Dodd appointed him to the Grand Council of Cryptic Masons and he served Colorado as Most Illustrious Grand Master in 2018. In 2021, he was elected as the Grand Treasurer for all three York Rite bodies, and has agreed to continue to serve the York Rite in that role again for 2024-2025.

He's also President of the Aurora Shrine Club, is on the Ceremonial Divan at El Jebel Shrine, and is active in a number of other bodies including the York Rite College, National Sojourners, the Knight Masons, the Red Cross of Constantine, KYCH, and AMD.

Despite all of his Masonic obligations, Illustrious Brother Tommy actually has a full life. He has been married since 2012, and his wife has three adult children. [10214013] They bought a travel trailer a few years later, and have enjoyed traveling around the country when he can break free from the constant pull of Masonry. He is a target shooter but said with a bit of regret that his wife doesn't share his enthusiasm for firearms and shooting. He's also an avid coin collector.

I asked our Illustrious Brother what he's going to do once he's retired (again). The Thomp-sons are going to travel “a lot more.” He did make a point to assure me that he'll still be around the Consistory and will stay involved and continue to help. I'll be sure to remind him of that next time I need to fill a role in a degree!

[Editor Note: I've already warned Illustrious Brother Tommy about the 4 essential rules of re-tirees—with the fourth being the “Grand Word” (NO) because everyone will look at him and say “ask him to do it, he's retired now and has all the time in the world...NO.]

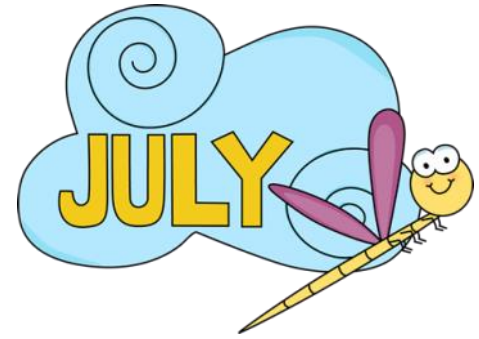

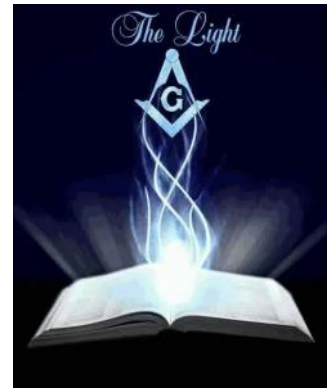
