## The Blue Forget-Me-Not



I'm sure most of us have seen or heard the story of the Blue Forget-Me-Not (perhaps you've seen it described as "Das Vergissmeinnicht" on a note given to you when you received the pin. Over the years, I've seen various incarnations of the story, as well as many nay-sayers claiming there is no way that the story could be true for various reasons.

As part of my recent move from Boulder to Thornton, I was clearing out a number of things and ran across my pin that was presented to me by a representative of the American Canadian Grand Lodge AF&AM within the United Grand Lodges of Germany (that's a complete story in itself) when I was stationed in Scotland. The story on their card matches probably 90-95% with that of a similar card supplied by Toye, Kenning & Spenser, Ltd, the official paraphernalia supplier for Masons in the UK. So, whether you believe it or not, pay more attention to the very last paragraph in this little "dissertation" on the beloved emblem of the craft in Germany.

As early as the year 1934, soon after Hitler's rise to power, it became apparent that Freemasonry was in danger. In the same year, the German Grand Lodge of the Sun in Bayreuth (one of the pre-war German Grand Lodges), realized the imminent problems facing them and elected to wear a little blue flower, the Forget-Me-Not, in lieu of the traditional Square and Compasses, as a mark of identity for Masons. It was felt the new symbol would not attract attention from the Nazis, who were in the process of confiscating and appropriating Masonic Lodges and property. Masonry had gone underground and it was necessary that the Brethren have some readily recognizable means of identification.

Throughout the entire Nazi era, a little blue flower in a lapel marked a Brother. In the Concentration Camps and in the cities, a little blue Forget-Me-Not distinguished the lapels of those who refused to allow the Light of Masonry to be extinguished.

In 1947, when the Grand Lodge of the Sun was reopened in Bayreuth by Past Grand Master Beyer, a little blue pin, in the shape of a Forget-Me-Not, was proposed and adopted as an OFFICIAL Masonic emblem honoring those valiant Brethren who carried their work on under adverse conditions. At the Grand Masters Conference in the United States, Dr. Theodor Vogel, the Grand Master of the newly-formed VGLvD, AF&AM, presented one of the pins to each of the representatives of the Grand Jurisdictions with which the VGLvD AF&AM enjoyed Fraternal relations.



Thus did a simple flower blossom forth into a meaningful emblem of the Fraternity and became perhaps the most widely worn pin among Freemasons in Germany. In most of our (American Canadian Grand Lodge AF&AM) lodges, the Forget-Me-Not is presented to new Master Masons, at which time its history is briefly explained.

Now, before you start claiming the story cannot possibly be true - I won't waste my time listening to you—BECAUSE this story comes from the Germans themselves as well as the Europeans who lived through those days under threat of extermination. We didn't.

I call your attention as well to two other relevant stories from WWII and the Cold War. In WWII, there is a well-documented story of a (albeit clandestine) lodge being formed and worked by prisoners in a concentration camp under the noses of their guards. This lasted for years until they were liberated by the Allies, at which time, the secretary of the lodge made sure to recover the minute book(s) which were secreted below floorboards in one of the buildings.

**Liberté chérie** (French for "Cherished Liberty") was a Masonic Lodge founded in 1943 by Belgian Resistance fighters and other political prisoners at Esterwegen concentration camp. It was one of the few lodges of Freemasons founded within a Nazi concentration camp during the Second World War.

In August 1945 Luc Somerhausen sent a detailed report to the Grand Master of the Grand Orient of Belgium, in which he delineated the history of the lodge Liberté chérie. Luc Somerhausen died in 1982 at the age of 79. The last witness, Fernand Erauw, died at the age of 83, in 1997.

So, this is just the best known story of a lodge in a few of the Nazi camps—their stories are all similar.

Now, let's take a look at the Grand Lodge of Russia. The **Grand Lodge of Russia** (GLoR) ([Russian](#): Великая ложа России) is the [Regular Masonic jurisdiction](#) for [Russia](#). The [Grand Lodge](#) was established on 24 June 1995. It was the first national grand lodge to be created in the country after the closure of the original Russian grand lodges in 1922 by the Bolsheviks.

So, Masonry started in Russia in the 18<sup>th</sup> century and actively continued until around 1922 when the Leninist/Bolsheviks closed those lodges. BUT, isn't it peculiar that NO Masonic activity was noticed for all the years until the Soviet Union collapsed on December 25, 1991? In fact, when the collapse occurred, I distinctly remember reading about the revival of the Grand Lodge of Russia—which of course had been clandestine for so many years—and it appears it took probably 4-5 years after the collapse for the GL to negotiate with the various other Regular GL's around the world for formal recognition.

So, as you can readily see, Masonry CAN and HAS existed under tyrannical regimes, working quietly and extremely carefully, and resurfacing ONLY when the suppressing regimes have been removed and safety is assured. There's a lesson in this—if we pay attention.

### Scottish Rite Masonic Center Endowment Fund Contributions

**Scottish Rite Masonic Center Endowment Fund** - The Scottish Rite Masonic Center Endowment Fund is established to provide a permanent source of funds to support the preservation and maintenance of the historic Cathedral Building. The Scottish Rite Masonic Center is a 501 (c)(3) tax-exempt organization. Donations may be tax deductible as a charitable contribution. Please consult your tax advisor for specific details and advice.

Donations build the principle in the endowment. Once the Endowment Fund becomes substantially funded, the returns within the Endowment Fund; Capital Gains, Dividends, and Interest, will provide financial support into perpetuity. Thus guaranteeing building maintenance and preservation.

The Endowment Fund Trustees established the “**Cathedral Club**” to recognize those who donate to the fund. The Cathedral Club recognition levels are:

**Diamond** - \$100,000 and up

**Platinum** - \$50,000 - \$99,999

**Gold** - \$25,000 - \$49,999

**Silver** - \$10,000 - \$24,999

**Bronze** - \$5,000 - \$9,999

To become a member of the Cathedral Club, make a one-time donation corresponding to a particular level, or make on-going donations to the fund. To start a Cathedral Club membership at the Bronze level, make a donation in any amount and pledge to make on-going donations until \$5,000 has been donated. Movement between the levels is based upon cumulative donations.

Membership in the Cathedral Club is NOT limited to only individuals (or Masons). Businesses and organizations (Masonic and non-Masonic) are invited to join the club.

**Transportation Available** – Brethren, if you need a ride to a stated meeting, the reunion, or one of our events, call the office and let us know. We will send a ride-share service (Lyft or Uber) to pick you up and bring you back home, **at no expense to you**. The Consistory will pay the bill. **2025 Membership fee was payable December 31, 2024.** If you have not yet paid your 2025 membership fee, please do so and do not become delinquent. \$140 is a real bargain for membership in Denver Consistory. Like myself, Brother Mike is a Senior DeMolay, and we know that we owe a tremendous debt to that organization for its role in our development as young men. Brother Mike's words should inspire us all to dedicate some of our efforts, as Masons, to support DeMolay International and our local Chapters.

Especially for those who enjoy our ritual and the opportunities it gives us to express ourselves and the deep affection we have for the Fraternity, I recommend an article in Volume 27 (2019) of *Heredom* (the annual "transactions" publication of the Scottish Rite Research Society) entitled "DeMolay Ritual: Its History, Elements, Sources, & Power" by R. Stephen Doan, 33°.

### ...and another (with special gratitude) ...

To Illustrious Brother Keith Anderson and Brother Tony Clark, 32° KCCH, for Keith's brief remarks at our February Business Meeting and for Tony's moving Oration at the February Stated Meeting. The two of them adamantly deny coordination or collaboration on their messages relating to Masonic ethics and leadership, but they'd have been hard-pressed to link their messages more closely had they actually put their heads together! At any rate, their words "got me to thinking" (a risky venture) and put me on a path for what will appear here over the coming months.



## Nine Great Truths

Illustrious Brother Keith's and Brother Tony's messages did much to raise a question in my mind. Certainly, I thought, there must be a place where the most fundamental principles guiding the Craft have been distilled into a simple and straightforward message ... and one authored by a recognized authority within the Fraternity. But where? My quest, as it turned out, was quite a short one. I will admit that ***Morals and Dogma*** wasn't the first place I looked, but that was because I was biased by my own criteria of "simple and straightforward" - not the first words one usually employs when thinking about that author or that work! But that's where I found it.

Over the next few months (at least that's the plan, as I begin) we're going to explore a rather condensed presentation of Albert Pike's "*Nine Great Truths of Masonry*." What is essentially an "essay" within the pages of *Morals and Dogma* could serve as a primer for a lifetime in the Craft, and I hope that my own added comments might at least serve as a springboard for further exploration. The section of M&D that encompasses this material falls amid Pike's description of the lessons of the 26<sup>th</sup> Degree. In making our way through the nine items, we'll look at what SGC Pike had to say; what our present-day Illustrious Brother Arturo de Hoyos, 33° GC, KYCH, expands upon in his annotated *Morals & Dogma*; and I'll share a few thoughts too. According to Commander Pike, these *Nine Great Truths*—which you'll find elsewhere in this issue of *Rite Works* if you want to see them all together at the start, encompass the essentials of the Craft:

So, let's begin!

**Truth #1:** "No man has seen God at any time; that is, God is only spiritual." This first and foundational truth seems almost self-evident, but it is loaded with powerful implications for all faiths, dogmas, and theological systems. Pike expands upon this initial thought, as de Hoyos points out, by emulating the language of Article 1 of the Augsburg Confession, proclaiming that "He is One, Eternal, All-Powerful, All-Wise, Infinitely Just, Merciful, Benevolent, and Compassionate, Creator and Preserver of all things, the Source of Light and Life, coextensive with Time and Space; *Who thought, and with the Thought created the Universe and all living things, and the souls of men* [italics mine-[Bill](#)]: That Is—the Permanent; while everything beside is a perpetual genesis."<sup>1</sup>

This last statement is hugely significant, both as it encompasses the essence of the great theological systems but also as it is especially consistent with the idea of *Logos* in Greco-Roman Stoic thought and (even as it adopts the same term) with Christian doctrine. "In a later work<sup>2</sup> Pike clarifies this ancient dogma by explaining that the Divine Intellect creates through the Divine Word: 'The *Logos* is, according to Tatian<sup>3</sup>, the creative utterance, manifestation of that Thought, the Divine Intellect manifesting itself, was the creative agent of the Unknown Father.'" But why is this statement so important to Freemasonry?

I'll take a whack at that! I believe that there are four reasons. First, by taking a position on the nature of Deity in concert with Christianity (as well as with Judaism and Islam), Pike establishes the fact that the philosophical/doctrinal thinking of the Lodge is not in opposition to the Christian faith, or with the Western traditions generally. This is important both to establish that Freemasonry is consistent with essential Christianity and to reinforce that Masonry is not itself a religion!

Second, it is important that Pike takes pains to establish, as does the Hebrew “shema” and the Muslim “tawhid,” that there is one God, rather than many. As a student of theology, as well as of history and philosophy, SGC Pike understood that the tendency, in polytheistic systems, is to associate plural gods with certain aspects of the natural world and, thereby, to end up worshiping the creation rather than the Creator! Any tendency to even give a nod in that direction would risk giving credence to Freemasonry’s detractors.

Third, and perhaps for us most importantly, placing Masonry squarely within the boundaries of the Western spiritual tradition positioned it within those intellectual boundaries as well. As the Lodge is a product of Enlightenment thinking, this concept is important to reinforce. Our focus upon the value and improvement of the individual requires underpinning by a solid association with such progress also being the Will of God!

Fourth and finally, Commander Pike’s emphasis upon the essentially and exclusively spiritual nature of Deity effectively distances the Lodge from association with cults and false religions that proclaim their founders or leaders to be manifestations of the divine. Any philosophy—and especially one associated with religious faith—may be corrupted. But taking Freemasonry out of that realm, right at the start, at least separates the Craft in an essential way from this most abusive of cultish practice.

Brethren, I hope you’ll forgive the slow start, but the prologue necessary to kick off this study made it possible only to cover the first point of the nine. I promise to do better in the months ahead!

## Pike's Nine Great Truths of Masonry

1. No man has seen God at any time; that is, God is only spiritual.
2. The soul of man is immortal.
3. The Moral Sense of man derives from God and therefore has a divine source and is a divine imperative.
4. Moral truths are as real as physical truths. They are not created by God but are a part of His nature; therefore, morality is not an arbitrary law of God but a part of that goodness which constitutes His essence.
5. The distinction between good and evil is essential. Having the ability to make the distinction is a unique quality of man whose ability to do good is only made meaningful by his ability to do that which is not good.
6. There are no degrees in the practice of moral obligations; it is neither variable nor contingent. No excuse can justify one's failure to exercise the moral imperatives of a just life.
7. The immutable law of God requires, that besides respecting the absolute rights of others, and being just, we should do good, be charitable, and obey the dictates of the generous and noble sentiments of the soul. We are but the almoners of God's riches and thus charity can know neither rule nor limit. It is the most sacred of all Masonic obligations.
8. The laws which control and regulate the universe are those of motion and harmony. Evil is merely apparent, and all is, in reality, good and perfect. The existence of misfortune and adversity provides the opportunity for the expression of those virtues which ennoble the soul and elevate the spirit of man; thus is the evil of this world but part of the great plan of God for the betterment of man.
9. The last Great Truth of Masonry is the paradox of the equipoise of the infinite justice and infinite mercy of God; the former alone would call for man's utter destruction, the latter alone would permit the most offensive hedonism. Together they provide man with both retribution and forgiveness.

Joshua James Ruegsegger, 32°



Joshua Ruegsegger was born in Wheat Ridge, Colorado, and spent his formative years growing up in Thornton, Colorado. Today, he resides in Denver, Colorado, a city he has called home since adulthood. His academic journey took him to the University of Colorado at Boulder, where he pursued a primary focus in physics and a secondary concentration in mathematics. Joshua's curiosity and fascination with understanding the fundamental workings of the world drew him to these subjects. Though he entered college unsure of his career path, the challenging nature of physics equipped him with robust problem-solving skills that have proven invaluable throughout his life.

Joshua is unmarried, has never been married, and has no children. His personal life reflects a deep appreciation for meaningful connections, particularly those forged through Freemasonry. His introduction to the fraternity came in his early twenties through his best friend, who joined the Masons before tragically passing away at age 21. Though initially uninterested, Joshua remained close with his friend's family, including Steve Hubbard, a significant figure in his Masonic journey. Years later, in 2015, feeling isolated while living in Denver, Joshua sought the fraternal bond he had witnessed in Steve's life. Currently, Joshua is an active member of Denver Lodge Number 5, the Scottish Rite, and the Knights of Saint Andrew (KSA). He has taken on leadership roles, including serving as Master of Denver Lodge Number 5 last year, and being elected Treasurer for this year. Additionally, he holds the position of Senior Warden in the KSA. None of his family members, past or present, are Masons, making his journey a personal one within his family lineage.

Joshua's favorite Masonic activity is degree work, where he excels and finds great satisfaction in collaborating with his brothers to welcome new members. Beyond Masonry, he enjoys watching soccer - a sport he played growing up - and cheering for Denver's local teams. His time working at Eldora during college also sparked a lasting love for snowboarding.

Within the Scottish Rite, Joshua cherishes the Spring and Fall reunions, particularly his role in the costume crew - a natural fit given his introduction to Masonry by Steve Hubbard and Doc Powell. He has participated in the 16<sup>th</sup>, 25<sup>th</sup>, and 29<sup>th</sup> degrees, and serves as assistant director for the 23<sup>rd</sup> degree. What he values most about the Scottish Rite is the collective dedication of its members, whose teamwork exemplifies what can be achieved through collaboration.

Reflecting on his years in Masonry, he holds dear the lesson of collective achievement - how much can be accomplished when people unite toward a common goal. For now, Joshua has no further details to add, content with the rich experiences and relationships that define his Masonic journey to date.

## Interesting Facts about April

No one is SURE how the month ended up with its name, but some think it is named after the Greek Goddess of love, Aphrodite, while others think it comes from the Roman word "Aprillis".

The etymology of the word "April" comes from the verb "aperire," which means "to open" and symbolizes the arrival of Spring.
